Dear Ms. Chavez:

The Agency in accordance with the Federal Fungicide and Rodenticide Act as Amended (FIFRA) has completed reviewing all of the information submitted with your application to support the reregistration of the aforementioned product in connection the MGK 326 RED, and have concluded that your submission is acceptable.

The Agency is in the process of developing and improving the current Efficacy Assessment Guidelines for repellent products. The Agency intends to defer the determination of any related efficacy data requirements supporting the claims that may appear on this label until these Efficacy Assessment Guidelines are complete. When the guidelines are finalized, the Agency expects to issue a Data Call-In to address the revised guidelines to all registrants with registrations for personal repellent products that have not previously submitted efficacy data sufficiently consistent with the revised guidelines.

NOTE: This product is not being re-registered under FIFRA Sec. 4(g) at this time.

Farnam Companies, Inc. should also note that a notice of availability of EPA's reregistration eligibility decision (RED) documents for products containing:

- Pyrethrins was published in the Federal Register on July 26, 2006 (Volume 71, Number 143, Pages 42387-42389).
- Piperonyl butoxide was published in the Federal Register on July 26, 2006 (Volume 71, Number 143, Pages 42385-42386).
- MGK 264 was published in the Federal Register July 26, 2006 (Volume 71, Number 143) Page 42381-42383).

As a result of these REDs, additional data and/or labeling changes may be required for products containing pyrethrins and/or piperonyl butoxide, and MGK 264.

User should wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet. User should remove clothing immediately if pesticides get inside. As soon as possible, wash thoroughly and change into clean clothing.

ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters or rinsate.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not apply over cuts, wounds, or irritated skin. Do not apply near eyes and mouth. Apply sparingly around ears.

SHAKE WELL BEFORE EACH USE

DOGS AND CATS: To kill fleas, ticks and lice, thoroughly mix a half-ounce (1 tablespoon) of ADAMS PYRETHRIN DIP with 1 gallon of warm water. For outdoor animals in areas of severe infestations, 2 oz. (4 tablespoons) per gallon may be used. Make fresh solution daily. If animal's coat is very dirty, bathe first with an ADAMS shampoo. Dip should be applied to dry or damp (not wet) coat. Sponge or dip animal with diluted ADAMS PYRETHRIN DIP making sure all areas are soaked to the skin. Let dip dry on animal. DO NOT RINSE OFF! Repeat treatment every 7 days if necessary.

HORSES: Dilute and apply as directed for dogs and cats. Do not use on horses or foals intended for slaughter.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry area away from heat and open flame. Do not contaminate water, food or feed by storage or disposal. Do not transfer contents to other containers.

Disposal: Nonrefillable. If Empty: Do not reuse this container. Place in trash or offer for recycling if available. If Partly Filled: Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
