Response to label amendments to size and directions dated October 13, 2006.

The submission referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, is acceptable with the following comments:

Label Language

In the Note to Physician or Veterinarian text, the term "elevated" prothrombin times is the correct terminology.

Under the heading ENVIRONMENTAL HAZARDS, the third sentence has a typographical error in it. The sentence should state: "Do not apply this product directly to water or to areas where surface water is present or to intertidal areas below the 'mean' high water mark."

The additional weight designations are acceptable.

Conclusion(s)

Submit one (1) copy of the revised final printed label for the record before you release the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

ENVIRONMENTAL HAZARDS

This product is toxic to mammals and birds. Predatory and scavenging mammals and birds might be poisoned if they feed upon animals that have eaten the bait. Do not apply this product directly to water or to areas where surface water is present or to intertidal areas below the man high water mark. Do not contaminate water by cleaning of equipment or disposal of wastes.

User Safety Recommendations

Users Should:

- Wash hands before eating, drinking, chewing bum, using tobacco or using the toilet.
- Remove clothing immediately if bait gets inside. Then wash thoroughly and put on clean clothing.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its label.

READ ENTIRE LABEL, USE STRICTLY IN ACCORDANCE WITH PRECAUTIONARY STATEMENTS AND DIRECTIONS AND WITH APPLICABLE STATE AND FEDERAL REGULATIONS.

IMPORTANT: Do not expose children, pets or other nontarget animals to rodenticides. To help prevent accidents:

- 1. Store product not in use in a location out of reach of children and pets.
- 2. Apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears or other potentially destructive animals, or in areas prone to vandalism.
- 3. Dispose of product container, unused, spoiled and unconsumed bait as specified on this label.

Urban Areas: This product may be used in and around the periphery of homes, industrial, commercial and public buildings. This product may also be used in and around transport vehicles (ships, trains, aircraft) and related port or terminal buildings. This product may be used in alleys.

Non-urban Areas: This product may be used inside of homes and agricultural buildings.

Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food. Do not broadcast bait.

SELECTION OF TREATMENT AREAS

Determine areas where rats and/or mice will most likely find and consume the bait. Generally, these are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Protect bait from rain and snow. Remove as much alternative food as possible.

Each [name] Bait Bar weighs one pound [4 oz] [6 oz] [8 oz] [10 oz] [12 oz] [14 oz] and is scored to be broken into 2-oz pieces.

RATS: Apply two to eight 2-oz pieces of block (or one entire block) at each placement location. For burrow applications, insert one to two 2-oz pieces of block deep into each active burrow. Check treated burrows each morning and evening to make sure that baits have not been pushed out of burrows. Space bait placements 15 to 30 feet apart in infested areas. Maintain an uninterrupted supply of fresh bait for 10 days or until fresh signs of rat activity cease to appear.

MICE: Break block and apply one 2-oz piece per placement. Space placements at intervals of 8-12 feet. Maintain an uninterrupted supply of fresh bait for 15 days or until fresh signs of mouse activity cease to appear.

FOLLOW-UP: Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and leftover bait properly. To prevent reinfestation, eliminate sources of rodent food, water and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish bait as needed.

APPLICATION DIRECTIONS - BAIT CHUNKS

Each [name] weighs 2-oz.

RATS: Apply two to eight 2-oz chunks at each placement location. For burrow applications, insert one to two 2-oz chunks deep into each active burrow. Check treated burrows each morning and evening to make sure that baits have not been pushed out of burrows. Space placements 15 to 30 feet apart in infested areas. Maintain an uninterrupted supply of fresh bait for 10 days or until fresh signs of rat activity cease to appear.

MICE: Apply one 2-oz chunk per placement. Space placements at 8 to 12 foot intervals. Maintain an uninterrupted supply of fresh bait for 15 days or until fresh signs of mouse activity cease.

FOLLOW-UP: Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and leftover bait properly. To prevent reinfestation, eliminate food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish bait as needed.

STORAGE AND DISPOSAL

STORAGE: Store only in original container, in a cool, dry place inaccessible to children and pets.

DISPOSAL: If empty: Do not reuse empty container. Place in trash or offer for recycling if available.

If partly filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
