DIRECTIONS FOR USE

STORAGE AND DISPOSAL

Pesticide Storage

Keep away from fire and sparks.

Keep out of reach of children and animals. Store in original containers only. Store in a cool, dry place and avoid excess heat. Carefully open containers. After partial use, fold and roll back bags, clamp and close tightly. Do not put concentrate or other material into food or drink containers. Do not contaminate other pesticides, fertilizers, water, food or feed by storage or disposal.

In case of spill, avoid contact, isolate area and keep out of reach of unprotected persons. Contain spills. Call FMC collect: (716) 735-3765.

To confine spill: If liquid, dike surrounding area or absorb with sand, cat litter or commercial clay. If dry material, cover to prevent dispersal. Place damaged package in a holding container. Identify contents.

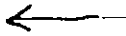
Apple: Cedar-apple Rust, Powdery Mildew and Scab

Peaches: Brown Rot and Scab

Apple and Peach Koloform is a wettable sulfur designed for use in the control of brown rot and scab on peaches and control of scab, powdery mildew and cedar rust on apples. Applications should be made during the bloom, petal fall and shuck fall stages of growth and at 7 to 14 day intervals (in accordance with local recommendations) thereafter at the rate of 6 pounds Apple and Peach Koloform per 100 gallons water.

Apple and Peach Koloform may also be used on certain other crops when a wettable sulfur is suitable for control of certain insects or diseases

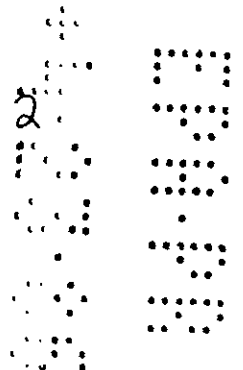
