DIRECTIONS FOR USE

This material is for use as a dust in early season applications, through first cover, for the control of scab on APPLES.

The rate of application varies with the size of the trees but in general ranges between 1/2 to 1 1/2 pounds per tree.

This material is not recommended for use during the bloom period, since some blackening of the blossoms may occur.

Applications of dusting and spraying materials containing sulfur should not be made just prior to or during periods of excessively high summer temperatures.

Do not use sulfur on apple foliage within ten days to two weeks of an oil spray.

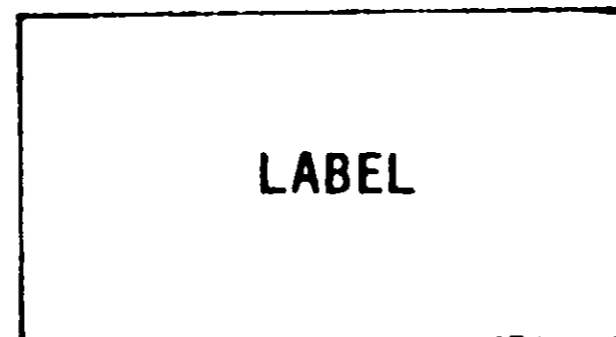
