DIRECTIONS FOR USE

**ON GRAPES** to control Pacific Mite, Two-Spotted Mite, White-shoulder Mite and Powdery Mildew. Use at the rate of 33 pounds per acre. Apply when mites or disease first appears and repeat as necessary. Do not make more than 3 applications during the fruiting period. May be applied up to the day of harvest.

**ON STRAWBERRIES** to control Two-Spotted Mite and Powdery Mildew. Use at the rate of 40 pounds per acre. Apply when mites or disease first appears and repeat as necessary. Do not make multiple applications at intervals less than 35 days. Do not apply within 6 days of picking berries. For Powdery Mildew control this material must be applied prior to disease development.

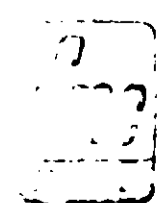
