## Directions for Use

**TOBACCO (Plant Bed)** Blue Mold, Flea Beetles - For each 100 square yards of plant bed, apply 2 to 3 pounds of dust depending on size of plants. Start applications when insects or disease first appear in the vicinity. Apply at 3 to 4 day intervals until transplanting time.

**TOBACCO (Field)** Blue Mold, Hornworms - Use 15 to 20 pounds of dust per acre. Good coverage is essential. Repeat as needed. If late applications are necessary, treat immediately after priming rather than before priming. Do not apply within 7 days of harvest.

### Usage Caution

Some phytotoxicity may occur on tender foliage in the presence of rain or high humidity of several days duration following dusting.

### Environmental and Disposal Cautions

This product is toxic to fish. Keep out of any body of water. Do not apply when weather conditions favor drift from the areas treated. Do not apply where runoff is likely to occur. Do not contaminate water by cleaning of equipment, or disposal of wastes. Apply this product only as specified on this label.

This product is highly toxic to bees exposed to direct treatment or residues on crops. Protective information may be obtained from your Cooperative Agricultural Extension Service.
