## DIRECTIONS FOR USE

Thorough coverage to upper and lower leaf surfaces is necessary for good control. May be applied by ground or air.

**STRAWBERRIES:** Strawberry Fruit Rot, Strawberry Aphid, Spittlebug – Use 40 to 50 pounds per acre. Apply when insects or disease first appear and repeat as required to maintain control. During the fruiting period do not reapply within 15 days or more than twice within a 35 day period when fruit is present. Do not apply within 4 days of picking berries. For proper disease control new growth should be protected throughout the growing season. If additional applications are required for disease control within the time limitations of this product use a suitable fungicide.

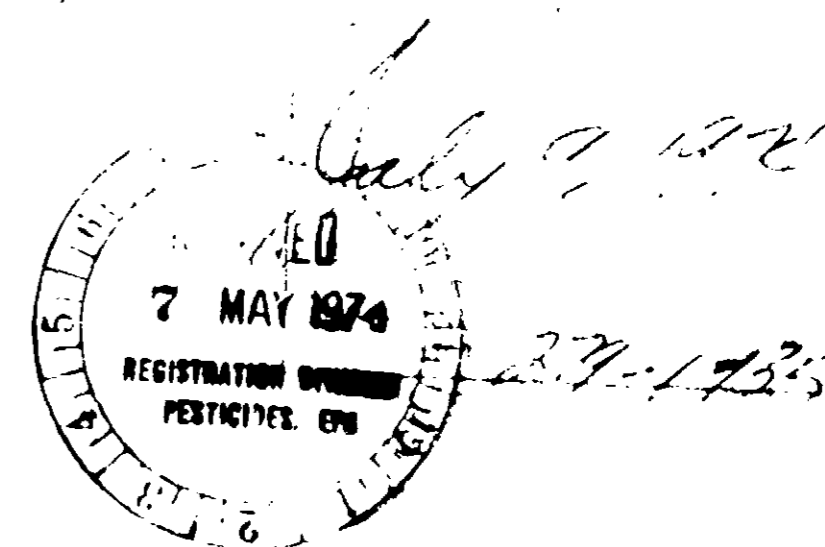

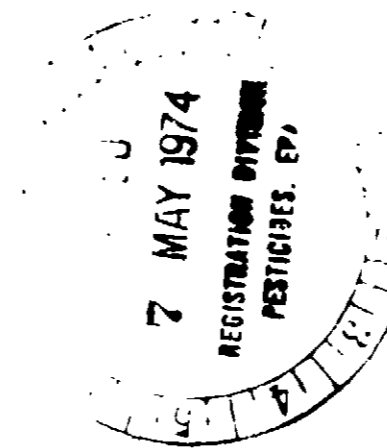
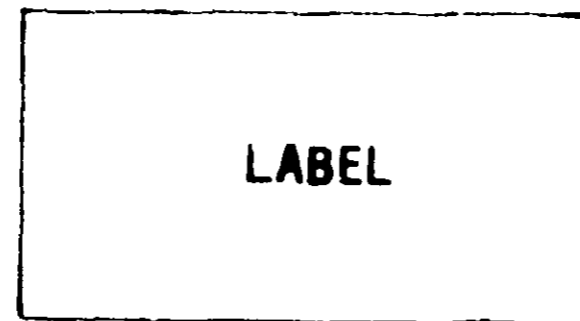
