Liquid MC Defoliant may be applied by ground or air. Material is to be diluted with the proper amount of water, not to be applied straight. Thorough coverage is essential for adequate defoliation and a second application may be necessary under some conditions. The spray must penetrate to all leaves as only those actually sprayed will be defoliated. **GROUND SPRAYER APPLICATION:** Add the recommended amount of Liquid MC Defoliant in sufficient water to give adequate coverage. This will range from 15 to 30 gallons of water per acre according to crop and size of plants. Six to eight nozzles per row are usually necessary to obtain good coverage with ground sprayers. **AIR APPLICATION:** Apply the required amount diluted to 10 gallons of water per acre. For best results the swath width should not exceed the wing span. Do not apply in windy weather or at mid-day heat.

COTTON: Use 2 to 2½ gallons per acre in necessary amount of water by ground or airplane application. Do not apply within 7 days of harvest. Do not graze treated areas or feed gin waste to livestock.

proper results. Slight yellowing of foliage and a reddish tinge on the leaves and stems are the usual signs of maturity. Leaves of a mature plant are less firmly attached and can be dislodged with a clean break by a slight downward pull. Plants should not be drought stricken as tough wilted leaves do not permit proper uptake of the chemical. Defoliants applied when plants are drought stricken usually cause the leaves to die, but remain on the plant. Dews are not normally necessary with Liquid MC Defoliant. Cold temperatures will decrease the efficiency of this material.




