Thoroughly mix in sufficient water per 100 gallons or amounts required to treat one acre. When using this material in the same spray tank with wettable powders, add the wettable powders first, and after they are thoroughly dispersed in the water, add this material to the tank last. Apply when mites first appear and repeat as required to maintain control. Apply to both upper and lower leaf surfaces. Observe use limitations. Observe days interval between last application and harvest indicated by number in () following crop.

APPLE (40): European Red Mite, Two-spotted Mite, Mc-Daniel Mite, Canadensis Mite, Carpini Mite, Schoenii Mite, Brown Almond Mite - Use 1 qt. per 100 gals. Do not apply more than 4 applications during the fruiting period, and do not apply more than 500 gals. of spray per acre per application.

APPLE (20): European Red Mite, Two-spotted Mite, Mc-Daniel Mite, Canadensis Mite, Carpini Mite, Schoenii Mite, Brown Almond Mite - Use 1 gt. per 100 gals. Do not apply more than 2 applications during the fruiting period, and do not apply more than 500 gals. of spray per acre per application.

Do not use on Astrachen, Davey, Duchess, Margaret Pratt, Melba, Wealthy, Williams Red (Red Williams), Yellow Transparent or any varieties maturing at or before early McIntosh or on Crimson and N. J. #3 (Brite Mac) apples as injury is likely to occur.

Do not feed pomace from treated apples to livestock.

CHERRY: European Red Mite, Two-spotted Mite, McDaniel Mite, Brown Almond Mite – Use 1 gt. per 100 gals. Do not use more than 500 gal. of spray per acre per application. Use as a post-harvest treatment only.

PEACH (30): European Red Mite, Two-spotted Mite, Mc-Daniel Mite, Brown Almond Mite – Use 1 qt. per 100 gals. Do not apply more than 2 applications during the fruiting period. Do not apply more than 500 gals. of spray per acre per application.

PEAR (30): European Red Mite, Two-spotted Mite, McDaniel Mite, Brown Almond Mite, Canadensis Mite, Carpini Mite, Schoenii Mite – Use 1 gt. per 100 gals. Do not apply more than 500 gals. of spray per acre per application. Do not apply more than 3 applications after the first cover spray.


