

First Aid

If Swailowed Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger or blant object. Do not induce vomiting or give anything by mouth to an unconscious person. Get medical attention. If breathing has stopped—start artificial respiration immediately and maintain until a doctor sees victim.

If In Eye Flush eye for 15 minutes with plenty of water. Call a physician immediately.

If On Skin or Clothing in case of contact immediately flush skin or eyes with water for at least 15 minutes while removing contaminated clothing and shoes.

Antidote

Note to Physician Active ingredient is a cholinesterase inhibitor. Patient should be kept under observation for 48 hours. Alropine is antidotal. Give 4 mg. atropine sulfate intramuscularly or intravenously. Repeat every 15 minutes until patient is fully atropinized. Do not give morphine.


