The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, Rodenticide Act, as amended, is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed.

- Under Precautionary Statements add the following text:Fatal if swallowed or inhaled. Harmful if absorbed through skin. Avoid contact with skin, eyes or clothing. Do not breathe vapor or spray mist.
- Under Environmental Hazards: Revise the third and fourth sentences as follows:Do not apply directly to water, to areas where surface water is present, or to intertidal areas below the high water mark. Due to the risk of runoff and drift, do not apply within a distance of 300 feet of lakes, ponds, streams and estuaries.
- Under Physical and Chemical Hazards, revise the statement 3. to read:Do not use, pour, spill or store near open flame.
- Under Storage and Disposal add the the following additional statement under Pesticide StorageKrep away from heat, open flame or sparks.
- As directed in the Agency's letter dated June 3, 1994, please make the following revisions:

- a. Add "Organophosphate" to your label in one of the locations shown in Section E of Part 2 of the Product Worksheet in Supplement Three-A to PR Notice 93-7.
- b. Insert the following statement above the Agricultural Use Requirements box: "Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the Agency responsible for pesticide regulation." The exact location is shown in Section F on Part 2 of the Product Worksheet in Supplement Three-A to PR Notice 93-7.
- c. Delete the 72-hour arid area REI statement and the notification statement from your label. EPA has determined that they are not required for products containing methyl parathion as the sole active ingredient.
- d. Correct the typographical errors circled on the proposed label.
- e. Delete the crossed-out statements on your proposed label. They are redundant statements.



STATEMENT OF PRACTICAL TREATMENT

Call a doctor (physician), clinic or hospital immediately. Explain that the victim has been exposed to a mixture of methyl parathion, endosulfan (an organochlo-nine) and xylene range aromatic solvents and describe his condition.

If breathing has stopped, start artificial respiration immediately and maintain until doctor sees victim.

If swallowed: Call a physician or Poison Control Center immediately. Consideration should be given to reducing ingestion exposure by gastric lavage with an endotracheal tube in place. Vomiting should be induced under medical supervision. Drink 1 or 2 glasses of water and induce vomiting by giving one ounce of syrup of ipecac or by touching the back of the throat with a finger. Do not induce vomiting or give anything by mouth to a person who is unconscious or convulsing. Do not give animal or vegetable fats, as they enhance absorption cf endosulfan.

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. See doctor immediately.

NOTE TO PHYSICIAN

The symptoms from absorption of this product are likely to be the result of methyl parathion and endosulfan, treatment should be directed towards the relief of cholinesterase inhibition and the contrc. of convulsions.

Antidote -- administer atropine sulfato in large doses, TWO to FOUR mg. intravenously or intramuscularly as soon as cyanosis is overcome. Repeat at 5 to 10 minute intervals until signs of at opinization appear. 2-PAM chloride is also antidotal and may be administered in conjunction with atropine. This product conwith an endotracheal tube in place. MORPHINE, RESERPINE, PHENOTH-IAZINES AND THEOPHYLLINE ARE PROBABLY CONTRAINDICA ED. Epinephrine is contraindicated due to cardiac muscle stimulation. Parathion is a strong cholinesterase inhibitor affecting the central and peripheral nervous systems and producing cardiac and respiratory depression. At first sign of pul-monary edema, the patient should be given supplemental oxygen and treated symptomatically. Continued absorption of the poison may occur and fatal relepses have been reported after initial improvement; VERY CLOSE SUPERVISION OF THE PATIENT IS INDICATED FOR AT LEAST 48 HOURS. Endosulfan is a central nervous system stimulant. There is no specific antidote. Central nervous system stimulation can be controlled with diazepan (i.v.), barbituric acid derviatives such as phenobarbitol may be used additionally.

Carrots (15): Flea Beetle, Green Peach Aphid—Use 1 to 2 quarts per acre. Armyworm, Leafhoppers—Use 2 quarts per acre. Do not exceed 2 applications per season. Do not use tops for food or feed.

Celery (Whole Plant) (15): Aphids Including Green Peach Aphid, Cabbage Looper, Flea Beetles—Use 1 to 2 quarts per acre. Armyworms, Leafhoppers—Use 2 quarts per acre. Do not exceed 3 applications per season.

Collards (21): Cabbage Looper, Diamondback Moth Larvae, Harlequin Bug, Imported Cabbageworm—Use 1½ quarts per acre. Do not exceed one application per season.

Kale (21): Cabbage Flea Beetle Harlequin Bug, Imported Cabbageworm—Use 11/2 quarts per acre. Do not exceed one application per season

Lettuce (21): Aphids including Green Peach Aphid, Cabbage Looper, Diamondback Moth Larvae, Armyworms, Flea Beetles, Imported Cabbageworm, Leafhoppers—Use 1½ to 2 quarts per acre. On head lettuce do not exceed 3 applications after thinning. Remove wrapper leaves at harvest. On leaf lettuce, do not exceed 2 applications per season. All uses: Do not feed crop refuse to livestock. Do not exceed 6 quarts per me per year.

Mustard Greens (21), Turnip Greens (21): Aphids, Cabbage Looper, Imported Cabbageworm—Use 1½ quarts per acre. Do not exceed one application per season.

Peas, Succulent (Northwest Only) (10): Pea Aphid, Pea Weevil—Use 2 quarts per acre. Do not exceed two applications per year. Use only on peas when crop is to be harvested by combine. Do not feed treated vines or threshings to livestock or allow livestock to graze in treated fields. Do not apply if the crop or weeds in the treatment area are in bloom.

Spinach (21): Armyworm, Crown Mite, Flea Beetles, Green Peach Aphid, Leafhoppers—Use 1½ quarts per acre. Do not exceed one application per season.
