

## STATEMENT OF PRACTICAL TREATMENT

Call a doctor (physician), clinic or hospital immediately. Explaintment the victim has been exposed to a modure of methyl parathion (an vigeorgatiosphilte), endosulfan (an organochiorine) and xylene range aromatic solvents and describe his condition.

If breathing has stopped, start antificial respiration immediately and maintain until doctor sees victim.

If swallowed: Call a physician or Poison Control Center immediately, Consideration should be given to reducing ingestion exposure by gastric lavage with an endotracheal tube in place. Vomiting should be induced under medical supervision. Drink 1 or 2 glasses of water and induce vomiting by giving one ounce of syrup of ipecac or by touching the back of the throat with a linger, Do not induce vomiting or give anything by mouth to a person who is unconscious or convulsing. Do not give animal or vegetable fats, as they enhance absorption of endosulfan.

in case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. See doctor immediately.

#### NOTE TO PHYSICIAN

The symptoms from absorption of this product are likely to be the result of methyl parathion and endosulfan, treatment should be directed towards the relief of cholinesterase inhibition and the control of convulsions.

Antidote-administer atropine sulfate in large doses, TWO to FOUR mg. intra-Anibole—achimister above subject in targe objects. Two to PODA mc. Incla-minute intervals until signs of atropinization appear. 2-PAM chloride is also arro-dotal and may be administered in conjunction with atropine. This product con-tains light aromatic hydrocarbons that can produce a severe pneumonitis or pu-monary edema if aspirated. Consideration should be given to gastric lavage with an endotracheal tube in place. MORPHINE, RESERVINE, PHENOTH-IAZINES AND THEOPHYLLINE ARE PROBABLY CONTRAINDICATED. 


