DIRECTIONS FOR USE

CITRUS (Grapefruit, Oranges, Tangelos and Tangerines): Rust Mite, Red Mite, Texas Mite and Six-spotted Mite.

Apply at the rate of 50 - 75 pounds per acre. On grapefruit, oranges, tangelos and tangerines do not apply within 90 days of preceding treatment. May be applied up to the day of harvest. Do not apply on tangerines more than twice per season.

EGGPLANTS: Red Spider and Two-Spotted Mite

Apply at the rate of 15 - 25 pounds per acre when mites first appear and repeat as required to maintain control. Dust plants thoroughly paying particular attention to the underside of leaves.

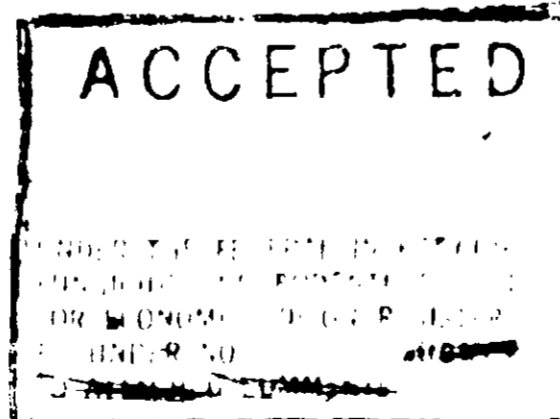

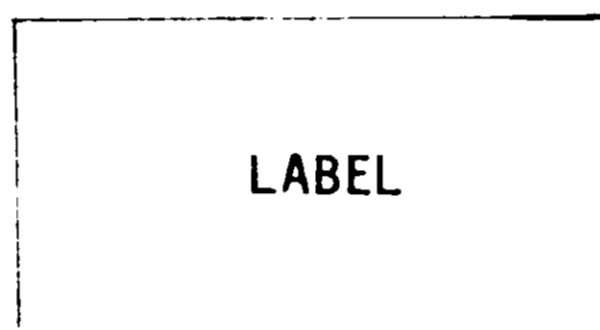
Do not apply to citrus within 3 weeks before or after an application of oil.
