RICE - Arkansas, Louisiana, Mississippi and Texas: Rice Water Weevil and Mosquitoes - Apply 15 to 20 pounds of Furadan 3 Granules per acre 1 day before or within 7 days after permanent flooding. Do not make more than one application per season. Occasional tip burn may occur when propanil is employed for weed control.

For effective control of the dark rice field mosquito, application must be made within 2 to 4 days after the field has been flooded.
