



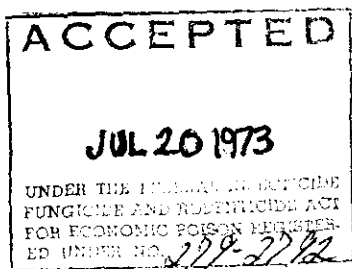

DIRECTIONS FOR USE

RICE - in Arkansas, Louisiana, Mississippi, Texas: For control of Rice Water Weevil and Mosquitoes apply 15 to 20 pounds of Furadan 3 Granules per acre one day before or within 21 days after permanent flooding. Do not make more than one application per season. The subsequent use of propanil herbicide may result in crop injury.

For effective larval control of the dark rice field mosquito, application must be made within 2 to 4 days after the field has been flooded.
