GENERAL INFORMATION

FUNDAL SP is a completely water soluble Miticide/Insecticide for the control of a broad range of mite eggs, nymphs, and adults and certain insect pests of fruit trees. FUNDAL SP is suitable for use in all types of ground sprayers and for application by aircraft.

PRECAUTIONS

Do not spray shortly before rainfall.

Prepare fresh sprays daily. Do not allow prepared solutions to stand overnight.

Do not use FUNDAL SP in alkaline solutions such as those containing lime-sulfur or Bordeaux.

Do not allow animals to graze in areas treated with FUNDAL SP.

Discard unused spray mixture or empty container by burying in non-crop lands away from water supplies or by burning. Stay out of smoke.

SEE REAR LABEL FOR DIRECTIONS FOR USE AND ADDITIONAL PRECAUTIONS

solve FUNDAL SP by stirring with a paddle.

FUNDAL SP is recommended to be used at the rate of ½ pound per 100 gallons of spray for the control of mites and insects listed in the table below.

This dosage of FUNDAL SP is based on dilute full coverage sprays from conventional sprayers applying 400 to 800 gallons of spray per acre. When lower spray volumes are applied, as from a concentrate sprayer or by aircraft, increase the concentration of FUNDAL SP in the spray mixture in order to apply the amount per acre equivalent to a dilute spray.

Most orchards of bearing standard size trees will require at least 2 lbs. of FUNDAL SP per acre for satisfactory results.

^{*}Non-bearing trees are those that will not bear fruit within one year after treatment.

USE LIMITATIONS

To avoid excessive residues observe the following spray and timing restrictions:

Apple Post-Bloom: Do not apply more than 3 times while fruit is on the tree or less than 14 days before harvest.

Pear Post-Bloom: Do not apply more than 3 times while fruit is on the tree or less than 28 days before harvest.

Peach, Nectarine: Do not apply when fruit is present in any form
