

DIRECTIONS FOR USE

SUGARCANE: Sugarcane borer - Apply 10 to 15 pounds FURADAN 5 Granules per acre using ground or aerial equipment. Check sugarcane fields weekly, beginning in early June and continuing through August. Make first application only after visible joints form and 5% or more of the plants are infested with young larvae feeding in or under the leaf sheath and which have not bored into the stalks. Repeat whenever field checks indicate the infestation exceeds 5 percent. Do not apply within 17 days of harvest. Do not use in Hawaii.
