DIRECTIONS FOR USE

STANDING WATERS, SHALLOW PONDS, LAKES, WOODLAND POOLS: For the control of mosquito and midge larvae use 5 to 10 pounds per acre. Apply uniformly around the edges of water, only where larvae are breeding.

TIDAL WATERS, MARSHES, SWAMPS AND WATERS HIGH IN ORGANIC CONTENT: For the control of mosquito and midge larvae use 10 to 20 pounds per acre. Apply uniformly around the edges of water, only where larvae are breeding.

ENVIRONMENTAL AND DISPOSAL CAUTIONS

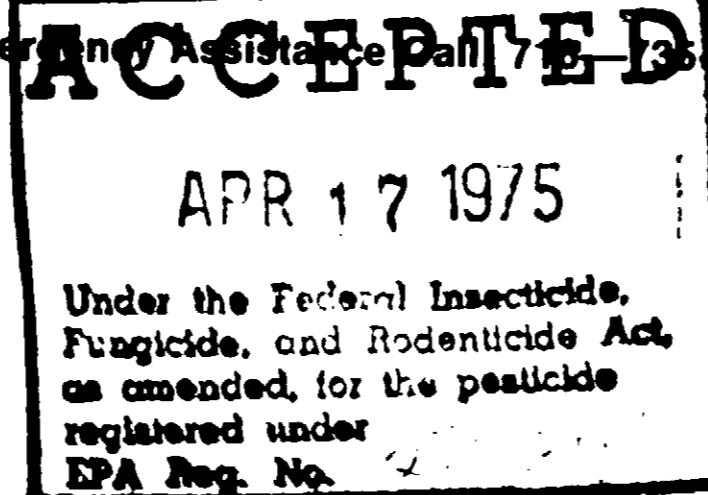
