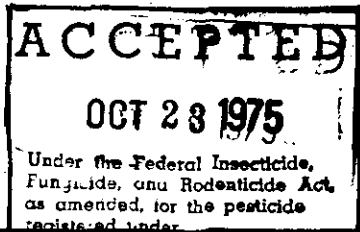

DIRECTIONS FOR USE

BANANAS and PLANTAINS - Nematodes, Weevils

AT PLANTING TIME: Use 25 to 30 grams of FURADAN 5% Granules per unit of production (cepa). Apply 16 to 20 grams to the planting hole and 9 to 10 grams to the soil surface (after the hole has been covered). Retreat soil surface with 40 grams at 4 months and again at 8 months after planting.

ESTABLISHED PLANTINGS: Use 40 to 50 grams of FURADAN 5% Granules per unit of production (cepa). Make two (2) applications per year. Apply 8 to 10 grams of FURADAN 5% Granules around the base of the mother, daughter, and grand-daughter plants and 32 to 40 grams of FURADAN 5% Granules distributed over an area of 50 cms around the producing unit (mother, daughter and granddaughter plants).

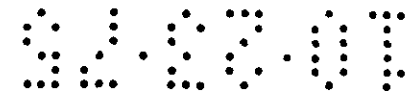
