DIRECTIONS

Use as a spot treatment on localized surface areas only.

To operate: Holding can upright, orifice directed toward surface to be treated, press actuator button.

Cockroaches, Ants, Sliverfish, Spiders, Crickets, and Earwigs: Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices, along baseboards and door sills and frames, bohind and beneath sinks, stoves, refrigerators, and cabinets and around garbage cans, plumbing and other utility installations.
