PRECAUTIONARY STATEMENTS

Hazards to Humans (and Domestic Animals)

Danger

Causes irreversible eye damage. May cause allergic skin reactions. Harmful if swallowed or inhaled. Do not get in eyes. Wear goggles or face shield when handling. Avoid contact with skin and clothing and breathing of dust. Remove and wash contaminated clothing before reuse.

Physical or Chemical Hazards

Applications of materials containing sulphur should not be made just prior to or during periods of excessively high temperatures or within 10 days to 2 weeks of an oil spray.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Do not apply this product in such a manner as to directly or through drift expose workers or other persons. The area being treated must be vacated by unprotected persons.

Do not enter treated areas without protective clothing for 24 hours.

Protective clothing means, at least, a hat or other suitable head covering, a long sleeved shirt and long legged trousers or a coverall type garment (all of closely woven fabric covering the body, including the arms and legs), shoes and socks.

Because certain states may require more restrictive reentry intervals for various crops treated with this product, consult your State Department of Agriculture for further information.

Written or oral warnings must be given to workers who are expected to be in a treated area or in an area about to be treated with this product. Inform workers of areas or fields that may not be entered without specific protective clothing, period of time field must be vacated and appropriate actions to take in case of accidental exposure. In case of accidental exposure to pesticide spray or dust, wash the skin thoroughly with soap and water. Remove contaminated clothing and wash before reuse. If in eyes, flush with plenty of water. If inhaled, go to an area where the pesticide has not been applied. Get medical attention if needed.

Storage and Disposal

Pesticide Storage

Keep out of reach of children and animals. Store in original containers only. Store in a cool, dry place and avoid excess heat. Carefully open containers. After partial use, fold and roll back bags, clamp and close tightly. Do not put concentrate or dilute material into food or drink containers. Do not contaminate other pesticides, fertilizers, water, food or food by storage or disposal.

To confine spill: If liquid, dike surrounding area or absorb with sand, cat litter or commercial clay. If dry material, cover to prevent dispersal. Place damaged package in a holding container. Identify contents.

Pesticide Disposal

Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal

Completely empty bag into application equipment. Then dispose of empty bag in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.

Do not use for dried fruit.

Apply when disease first appears and repeat as necessary to maintain control. May be applied by ground or air. Do not allow workers to re-enter treated area to engage in any activity requiring substantial contact with treated foliage within 24 hours of application. Observe days interval between last application and harvest indicated by number in () following crop.

Grapes (1): Botrytis Rot (Bunch Rot), Storage Rot and Powdery Mildew—Use 30 pounds per acre. Begin application while clusters are loose and repeat at two week intervals. Ground application equipment preferred. Concord and other Labrusca type grapes may be injured by sulphur.

Nectarines (1): Brown Rot, Rhizopus Rot and Powdery Mildew—Use 50 pounds per acre.

Peaches (1): Brown Rot or Blossom Blight (Monilinia), Peach Scab and Powdery Mildew—Use 60 pounds per acre. Apply at pink bud and full bloom. Fruit Decay (Monilinia), Brown Rot (Rhizopus) and Powdery Mildew—Use 60 pounds per acre. Apply 16 days, 10 days and 1 day prior to harvest.
