HOME LAWNS and ORNAMENTAL TURF AREAS: Chinch Bugs, Sod Webworms (Lawn Moths), Ants, Brown Dog Ticks, Crickets, Cutworms, Earwigs, Sowbugs (Pillbugs) \*Hyperodes (Turfgrass) Weevils and \*White Grubs (Larvae of European Chafer and Japanese Beetles) — Use 50 pounds per acre. For best results, treat when insects are young and actively feeding near the soil surface, usually during late July and August. Retreat as necessary. Consult your local Agricultural Extension Service specialist for the proper time to treat in your area for control of White Grubs and Hyperodes (Turfgrass) Weevils.
