
The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is accepted subject to the comments listed on the enclosed sheet. A copy of your proposed labeling stamped "ACCEPTED WITH COMMENTS" is enclosed.

# SERIOUS ERROR(S) ON SUBMITTED LABELING:

EPA has determined that one or more of the errors on the labeling you submitted to the Agency is categorized as "serious" as defined in PR Notice 93-11. In general, serious errors are those that may create a potential for harm to workers, handlers, other persons. or the environment; or those that prevent the achievement of the basic goals of the Worker Protection Standard (WPS) or FIFRA.

- 4. Proposed plan for assuring that product with the incorrect labeling in your control, as well as that in the hands of dealers/distributors/users, will be corrected. The plan must include your proposal for assuring that the labeling is corrected as soon as possible.

The following specific comments pertain to your WPS labeling submission concerning the product cited above:

The requirement under the heading "Personal Protective Equipment" must state: "Applicators and other handlers must wear:". Cross out your lead-in statement and replace it with correct one. EXCEPTION: If you have an entirely separate PPE section specifying what "Mixers and loaders must wear", the requirement under the heading "Personal Protective Equipment" must state: "Applicators and other handlers (other than mixers and loaders) must wear:". Cross out your lead-in statement and replace it with the correct one.

Add the following User Safety Recommendation to the label in the location shown in Section A on Part I of the Product Worksheet in Supplement Three-A to PR Notice 93-7: "Wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet.

The following statement on your proposed label is not required for this product: "Notify workers of the application by warning them orally and by posting warning signs at entrances to treated areas." Delete it from the Agricultural Use Requirements box.

Delete the crossed-out statements on your proposed label. They are redundant statements or phrases.

Mushroom Houses and Adjacent Premise Areas

For control of mushroom flies (Sciarid and Phorid adults):

Preparation of the Building Prior to Fogging:

- (1) Close all doors, windows and ventilators
- (2) Lock or barricade all entrances, turn off pilot lights.

Apply Pounce Mushroom Spraymist as a fogging or aerosol treatment at the rate of 2 to 2.5 ounces (0.05-0.0625 lb. a.i.) Pounce Mushroom Spraymist per 30 ounces of water or suitable diluent. Use 1 quart of solution per standard double (35,000 cu. ft.: 8,000 sq. ft.).

Use Pounce Mushroom Spraymist prior to filling house, during cool-down, during spawning up to pinning and between breaks. Do not use when mushrooms are present. Treat once daily or as needed when flies appear. Do not make more than 20 applications prior to pinning of first break. Apply no more than two applications between each break. Do not apply more than 30 applications total per crop of 5 breaks.

Do not apply within 3 days of harvest.

Length of exposure time should be limited to 1 hour, then ventilate the house. Use fans to ventilate in houses that do not have forced air cir-cula-
