When treating for Armyworms, Cutworms, European Corn Borer, Southwestem Corn Borer and Westem Bean Cutworm apply when eggs begin to hatch. For treatment of Stalk Borers, Pounce 1.5 G must be applied when or shortly before the Stalk Borer larvae are moving into the corn from the surrounding weeds and grasses. Mowing or burn-down herbicide is suggested to initiate movement of Stalk Borer larvae. Apply by aircraft broadcasting over corn plants or with ground equipment by directing the granule into the whorl.

Pis* jos: To control ants—Use Pounce 1.5 G at a rate of 26 pounds (0. Ind active) per acre. Apply as a broadcast treatment by ground equipment or aircraft when ants appear. Overhead moisture following application will enhance activity.

When treating for Armyworms, Western Bean Cutworm, Southwestern Corn Borer, and European Corn Borer apply when eggs begin to hatch. For treatment of Stalk Borer, Pounce 1.5 G must be applied when or shortly before Stalk Borer larvae are moving into sweet corn from the surrounding weeds and grasses. Mowing or burn-down herbicide is suggested to initiate movement of Stalk Borer larvae. Apply by aircraft by broning over sweet corn plants or with ground equipment by directing granule into the whorl.

Apply every five days or as needed. Do not apply more than 1.2 pounds active ingredient per acre per crop season. Do not apply within 1 day of harvest of ears or forage or livestock grazing.

Corn insecticide Applicator Settings

Pounce 1.5 G is a dense, free flowing insecticide requiring accurate equipment calibration to apply the recommended amount per acre. Calibrate your planter to the speed at which you plan to travel during planting operation. The following are approximate settings for guidance in calibration:

At Plant Use: To control armyworms and cutworms apply Pounce 1.5 G as an in-furrow, band or T-band treatment at a rate of 8 ounces per 1000 linear feet of row using a minimum 4" band as follows:

Pre-emergent Use: To control armyworms, cutworms and stalk borers Pounce may be applied in the time period from 14 days prior to planting up to emergence of the crop. Apply as a broadcast spray by ground or air or 4"-15" band using Pounce 1.5G at a rate of 6.7 to 13.3 pounds(0.10 to 0.20 pound active) per acre broadcast or 8 to 16 ounces per 1000 linear feet of row based on a 4" band and 40 inch row spacing. Linear row calculations should be used proportional to the standard Band Width/Row Width formula to adjust rates for different band widths or row spacings. Use the higher rates of Pounce 1.5G when incorporating into the soil without exceeding the recommended dosage.

Foliar Use: No change from current label.

Up to 0.6 pound active may be used per season. Do not make treatments less than 6 days apart or apply less than 30 days prior to harvest of grain or fodder (stover). Forage may be harvested within 1 day of application.

SWEET CORN:

At Plant Use: To control armyworms and cutworms apply Pounce 1.5 G as an in-furrow, band or T-band treatment at a rate of 8 ounces per 1000 linear feet of row using a minimum 4" band as follows:

Pre-emergent Use: To control armyworms, cutworms and stalk horers Pounce may be applied in the time period from 14 days prior to planting up to emergence of the crop. Apply as a broadcast soray by ground or air or 4"-15" band using Pounce 1.5G at a rate of 5.7 to 13.3 pounds(0.10 to 0.20 pound active) per acre broadcast or 8 to 16 ounces per 1000 linear feet of row based on a 4" band and 60 inch row spacing. Linear row calculations should be used proportional to the standard Band Width/Row Width formula to adjust rates for different band widths or row spacings. Use the higher rates of Pounce 1.5G when incorporating into the soil without exceeding the recommended dosage.
