Subject: Amendment – Response to the Agency's February 21, 2008 letter implementing spray drift language and Permethrin RED risk mitigation labeling Pounce 1.5G Insecticide EPA Reg. No. 279-3059 Your submissions dated July 3 and November 12, 2008

The amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable provided that you:

- 1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
- 2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
  - a. The paragraphs beginning with "Follow manufacturer's instructions for cleaning...etc" and "Discard clothing and other absorbent materials...etc" should be enclosed in a box with the heading "User Safety Requirements". In the next to last sentence of this section, revise "contaminated with this products concentrate" to read "contaminated with this product's concentrate.".
  - b. Under the heading "Buffer Zones", correct the website URL (address) for guidance to read as follows: <u>www.in.nrcs.usda.gov/technical/agronomy/newconbuf.pdf</u>. Also, qualify the site "ponds" to read "natural ponds" and qualify "streams" to read "permanent streams" under the subheadings "Buffer Zone for Ground Application" and "Buffer Zone for Aerial Application".

- d. In the Field Corn, Field Corn Grown for Seed, and Popcorn (At Plant Use) directions, for the note revise the maximum pounds a.i. per acre for the 20 inch row spacing to 0.15, which is the maximum rate per application for this crop.
- e. In the "Method of Application" entry for foliar uses on Sweet Corn, after "Apply every 3 days or as needed." add "Do not make applications less than 3 days apart.".
- f. In the "Corn Application Rates" paragraph, add as the last sentence "Do not exceed the maximum rate per acre application rate specified in the notes for each crop entry.".
- g. On page three, revise "should" to "must", so that the top sentence reads "Dealers Must Sell in Original Packages Only.".
- h. In the first sentence of the next-to-last paragraph of the "Conditions of Sale and Limitations of Warranty and Liability", revise "FMC or seller be liable..." to read "FMC or seller shall not be liable...".

A stamped copy of the label is enclosed for your records. Please submit three copies of the amended labeling bearing the above revisions before you release the amended label for shipment. Please note that acceptance of this amendment does <u>not</u> constitute reregistration of the subject product.


