### Non-PRIA Fast Track Label Amendment

FMC Corporation is submitting amended labels for the subject products. The label changes are to comply with container disposal language requirements from PR 2007-4. In this case, these statements have changed the rinsate from water to solvent due to the low solubility of the technical material in water.

In addition, food handling establishments have been removed from the technical labels since food handling uses are not currently approved for zeta-cypermethrin.

### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

#### **Pesticide Storage**

Do not store below 40°F.

Keep out of reach of children and animals. Store in original containers only. Store in a cool, dry place and avoid excess heat. Carefully open containers. After partial use, replace lids and close tightly. Do not put concentrate or dilute material into food or drink containers.

In case of spill, avoid contact, isolate area and keep out animals and unprotected persons. Confine spills. Call FMC: 1-(800)-331-3148.

#### Pesticide Disposal

Pesticide wastes may be hazardous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal Law. #### **Container Disposal**

Nonrefillable container. Do not reuse or refill this container. Triple rinse (or pressure rinse) as follows:

Triple rinse: Empty the remaining contents into a storage container or a mix tank. Fill the container ½ full with appropriate solvent¹. Replace and tighten closures. Tip container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into a storage container for later use or disposal, or into a mix tank for product formulation. Repeat this procedure two more times.

Pressure rinse: Empty the remaining contents into a storage container or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over storage container or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

Then offer for recycling if available or puncture and dispose in a sanitary landfill, or by other procedures approved by state and local authorities. If rinsate cannot be used, follow pesticide disposal instructions. If not triple rinsed, these containers are acute hazardous wastes and must be disposed in accordance with local, state and federal regulations. DO NOT cut or weld metal containers.

An appropriate solvent would include a solvent that will dissolve technical material. The rinsate may be used later to formulate a product or may be disposed in accordance with local, state and national environmental laws, rules, standards and regulations.
