- 3. Make the following label changes:
 - a. Revise the EPA Registration Number to read, "EPA Reg. No. 279-3154."
- b. Delete "Outdoor Uses" from your labeling. These uses are not on your reference product's labeling. Additionally the placement stations have not been evaluated for child resistant claims.
- c. Delete the phrases "even on food preparation surfaces or next to food." The Agency discourages reference or recommendation for use of pesticides next to food or food utensils regardless of it packaging. Such terms are considered vague and have the potential to mislead the user with respect to the safety of a pesticide.
- 3. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.



DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Break FluorGuard™ ant control baits apart from the plastic frame before placement.

Place station nearby ant trails or close to areas where ants are present. even on food preparation surfaces or next to food. Do not place baits on food preparation surfaces when food is being handled or on utensils that are used for food preparation. Also place adjacent to walls, electrical lines, potted plants, waste receptacles, sensitive electronic equipment. inside drop ceilings and wall voids or anywhere ant problems occur. To apply baits to vertical surfaces use the enclosed stickers. Sticker may pull paint, drywall or wallpaper off of surface when stations are removed.

Do not use residual sprays with or near FluorGuard™ Ant Control Baits

Ants will begin to feed - population reduction and less activity can be expected within 2 to 7 days.

Occasionally because of changes in food preferences, a listed ant colony may not feed upon FluorGuard bait. In these situations, offer another brand of baits and offer FluorGuard bait at a later date.

Outdoor Uses

Outdoor use of the bait are only allowed when the bait station is inserted into an outdoor placement station. The outdoor placement station with or without soil insert tube may be used to place bait stations within a tamper proof bait box. Ants readily enter the placement station and locate the ant bait within. The placement station may contain 1-4 bait stations either of FluorGuard or other FMC baits

Outdoor placement stations must be used outdoors but may be used

Tube may contain treated or untreated cardboard for use in the control of subterranean termites.

Outdoor placement stations may be reused.

The outdoor placement station, with or without soil insert tube, may be placed in, or nearby fireant or harvester ant colonies

FluorGuard™ baits (and several competitor baits) eventually become moldy if placed in high humidity areas.

FluorGuard™ ant bait stations may be filled or refilled with the same bait or another FMC bait or contain more than one type of FMC bait.

Note: Fire ant colonies usually overwhelm single bait stations. Two or more stations are usually required for colony control

For Effective Control

Use 3-4 baits for the average size room

Use 6-8 baits for heavy infestations.

Replacement is recommended after 3 months co when bait is almost entirely consumed (do not risk loss of control by allowing complete consumption.)
