Shake well before use. Adjust spray nozzle to deliver a stream for cracks and crevices or a coarse spray for other areas. Hold sprayer 12 inches from the insect or surface being sprayed. Spray until slightly wet without soaking. For localized application, do not apply as a space spray. Do not allow this product to contact food, foodstuffs, food preparation areas or utensils and water supplies.

Pest Control on Inside Surfaces

Do not allow this product to contact food, foodstuffs, food preparation areas or utensils and water supplies. Shake the contents of this package for 10 to 15 seconds before use. Apply as a coarse spray to localized inside surfaces of residential buildings including private homes, duplexes, townhouses, condominiums, house trailers, recreational vehicles, houseboats, apartment complexes, carports, garages, storage sheds, barns and other residential structures. For localized application only. Do not apply as a space spray.

Nuisance Pests Indoors: Apply as a coarse spray to localized areas to control ants, including Fire Ants, Pharoah (Sugar) Ants and others, beetles, including Carpet Beetles, Crickets, Earwigs, Firebrats, Fleas, Flies, mites, including Red Spider Mites, Mosquitoes, Moths, roaches, including Cockroaches, Silverfish, and spiders, including Black Widow Spiders and Ticks.

Spray dark corners of rooms and closets; cracks and crevices in walls; along baseboards; beneath and behind sinks, stoves, refrigerators and cabinets; around plumbing and other utility installations; around doors, window frames and wherever these pests may find entrance.

Thoroughly spray localized infestations in weeds or around ornamental plants. Repeat as needed.

To Attach Sprayer

Remove cap from container and replace with sprayer hose and cap assembly. Tighten securely.

To Use Sprayer

Turn sprayer nozzle one-half turn counterclockwise. Hold sprayer below the level of container and prime by pumping trigger 10-15 times until product is dispensed. Adjust nozzle to coarse spray.

After each use, thoroughly flush sprayer and hose with water. Return hose and cap assembly to container, tighten securely. Turn nozzle to "OFF" position, and store above level of liquid in container to prevent leakage.

NOTE: If sprayer does not function properly, remove nozzle cover and check nozzle hole and holes in rubber component for obstructions. Check to make sure nozzle is not in "OFF" position. Replace nozzle cover, return sprayer assembly to container and proceed.
