The application referred to above, submitted under the Federal Insecticide, Fungicide and Rodenticide Act, as amended is acceptable under FIFRA sec 3 (c)(5). In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal. **Pesticide Storage**

Do not store below 25°C. Product may crystallize at temperatures below 25°C (77°F). In the event that crystallization occurs, the material may be melted at temperatures not to exceed 85°C (185°F). Store in original containers only. Store in a dry place and avoid excess heat. Carefully open containers. After partial use, replace lids and close tightly. Do not put concentrate or dilute material into food or drink containers. Do not contaminate other pesticides, fertilizers, water, food or feed by storage or disposal.

In case of spill, avoid contact, isolate area and keep out animals and unprotected persons. Confine spills. **Call CHEMTREC** (Transportation and spills): (800) 424-9300.

To confine spill: Dike surrounding area or absorb with sand, cat litter or commercial clay. Place damaged package in a holding container. Identify contents.

Pesticide Disposal

Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal

Nonrefillable container. Do not reuse or refill this container. Triple rinse [or pressure rinse] as follows:

Triple rinse: Empty the remaining contents into a storage container or a mix tank. Fill the container ¹/₄ full with appropriate solvent ⁽¹⁾. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into a storage container for later use or disposal, or into a mix tank for product formulation. Repeat this procedure two more times.

Pressure rinse: Empty the remaining contents into a storage container or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over storage container or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

Then offer for recycling, if available, or reconditioning, if appropriate, or puncture and dispose of in a sanitary landfill or by incineration. Do not burn, unless allowed by state or local ordinances. If burned, stay out of smoke.

⁽¹⁾An appropriate solvent would include a solvent that will dissolve technical material. The rinsate may be used later to formulate a product or may be disposed in accordance with local, state and national environmental laws, rules, standards and regulations.
