### Quick Connect Sprayer

2. Insert plug into spout (on cap) until it clicks. [Icon]
3. Flip up spout. Open nozzle at end of sprayer. [Icon]

### How to Spray [Icon]

Shake well before use. Adjust spray nozzle to deliver a stream for cracks and crevices or a coarse spray for other areas. Hold sprayer 12 inches from the insect or surface being sprayed. Spray until slightly wet without soaking. For localized application, do not apply as a space spray. Do not allow this product to contact food, foodstuffs, food preparation areas or utensils and water supplies.

### Pest Control on Inside Surfaces [Icon]

Do not allow this product to contact food, foodstuffs, food preparation areas or utensils and water supplies. Shake the contents of this package for 10 to 15 seconds before use.
