Revise the front panel user statement to read as follows: "For use by individuals/firms licensed or restricted by the state to apply Insecticide products. For use to control ants (including imported fire ants) mole crickets and other listed pests on lawns in landscaped areas around residential, institutional, public, commercial and industrial buildings, parks, recreational areas and athletic fields".

Delete instructions for perimeter application. This type treatment is not appropriate for a product containing a fertilizer.

Grass Application: Broadcast Talstar[®] 0.069 GCGURR Granular Insecticide with 19-0-19 Fertilizer with suitable application equipment to ensure uniform coverage over the treatment area. Apply 3.33 to 6.66 pounds per 1,000 square feet to control the following pests.
