- Under #General Spartan DF Product Use Rates#, first paragraph, delete the following statement: #FMC. accepts no liability for potential crop effects that may result from the improper selection of Spartan Herbicide application rates, improper application, or the failure to follow recommended intervals for rotational crops.#
- 2. Under **Rotational Crop Guidelines*, Table 4, change the sweet potatoes intervals from **anytime** to **12 months*.
- 3. Under #Fallow or Post Harvest Burndown#, Table 8, list the specific registered crops that pertains to this section.
- 4. The Vegetable Disclaimer on page 16 is unacceptable. Replace with the following statements: #[Company name] intends to offer this product only to those end users and/or growers who have liability and indemnification agreements with [company name] for failure to perform and crop damage from use of [product name] on [crops]. If, after purchasing the product, the release of liability and indemnification is unacceptable to the user/grower, [company name] requests that the user/grower return [product name] to the place of purchase at once unopened.

This product when used on [crop] may lead to crop injury, loss, or damage [company] recommends that the user and/or grower test this product in order to determine its suitability for such intended use. [Company] makes the product available to the user and/or grower solely to the extent the benefit and utility, in the sole opinion of the

Do not apply more than the allowed amount of Spartan DF per acre per twelve-month period as stated in Table 2. The twelve-month period is considered to begin upon the initial Spartan application.

For any requirements specific to your State or Tribe, consult the Agency responsible for pesticide regulation.

GENERAL INFORMATION

Spartan DF is a selective soil-applied herbicide for the control or partial control of susceptible braddleaf grass and sedge weeds. Spartan DF is formulated as a 4 pound per gallon flowable containing the active ingredient, sulfentrazone. If adequate moisture (1/2" to 1") from rainfall or irrigation is not received within 7 to 10 days after the Spartan treatment, a shall be incorporation may be needed to obtain desired weed control. Wash incorporation may be needed to obtain desired weeds. Soil applications of Spartan must be made before crop seed germination to prevent injury to the emerging crop seedlings. When applications after placed readlayed, injury may occur if seeds are germinating or if they are located near the soil surface.

Observe all instructions, crop restrictions, mixing directions, application precautions, replanting directions, rotational crop guidelines and other label information of each product when tank mixing with Spartan.

Proper handling instructions: Spartan DF may not be mixed or loaded within 50 feet of any wells (including abandoned wells and drainage wells), sinkholes, perennial or intermittent streams and rivers, and natural or impounded lakes and reservoirs. This setback does not apply to properly capped or plugged abandoned wells and does not apply to impervious pad or properly diked mixing/loading areas.

Operations that involve mixing, loading, rinsing, or washing of this product into or from pesticide handling or application equipment or

containers within 50 feet of any well are prohibited unless conducted on an impervious pad constructed to withstand the weight of the heaviest load that may be positioned on or moved across the pad. Such a pad shall be designed and maintained to contain any product spills or equipment leaks, container or equipment rinse or washwater, and rainwater that may fall on the pad. Surface water shall not be allowed to either flow over or from the pad, which means the pad must be selfcontained. The pad shall be sloped to facilitate material removal. An unroofed pad shall be of sufficient capacity to contain at a minimum 110% of the capacity of the largest pesticide container or application equipment on the pad. A pad that is covered by a roof of sufficient size to completely exclude precipitation from contact with the pad shall have a minimum containment capacity of 100% of the capacity of the largest pesticide container or application equipment on the pad. Containment capacities as described above shall be maintained at all times. The above specific minimum containment capacities do not apply to vehicles when delivering pesticide shipments to the mixing/loading site. States may have in effect additional requirements regarding wellhead setbacks and operational containment.

Product must be used in a manner that will prevent back siphoning in wells, spills or improper disposal of excess pesticide, spray mixtures or rinsates.

APPLICATION INFORMATION Ground Application

Utilize a boom and nozzle sprayer equipped with the appropriate nozzles, spray tips and screens and adjusted to provide optimum spray distribution and coverage at the appropriate operating pressures. Utilize nozzles that produce minimal amounts of fine spray droplets to avoid spray drift or inadequate foliar and soil coverage. Apply a minimum of 10 gallons of finished spray per acre by ground. Be aware that overlaps and slower ground speeds while starting, stopping or turning while spraying may result in excessive application and subsequent crop response

Chemigation Application

Spartan DF may be applied through sprinkler irrigation systems including center pivot, lateral move, end tow, solid set, or hand move irrigation systems. Do not apply this product through any other type of irrigation system. Do not connect any irrigation system (including greenhouse system) used for pesticide application to a public water system. Crop injury, lack of effectiveness or illegal residues on or in the crop can result from non-uniform distribution of treated water. If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers, or other experts. A person knowledgeable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.

It is important to note that irrigation with highly alkaline water (high pH) following a Spartan DF soil application can also significantly increase the amount of sulfentrazone available in soil solution. Irrigation with water thaving a pH greater than 7.5 could result in adverse crop response. This response will ultimately depend on initial Spartan DF application rate. timing, amount and pH of irrigation water, and the sensitivity of the crop and the growth stage when irrigated. The risk of adverse crop response will lessen with advancing growth stages of most crops.

The system must contain a functional check valve, vacuum relief valve, and low-pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow. The pesticide injection pipeline must also contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump. The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops. The irrigation line or water pump motor when the water pressure switch, which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.

Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

Spartan DF should be metered into the irrigation system continuously for the duration of the water application. Spartan DF should be diluted in sufficient volume to insure accurate application over the great to be

There shall be a complete physical break (air gap) between the outpet end of the fill pipe and to top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe. Use nozzle types and arrangements that will provide optimum coverage while producing a minimum of fine droplets. Apply sufficient spray volume to achieve ad epuste coverage. Apply a minimum of 5 gallons of finished spray per dole.

Spray Drift Management

AVOIDING SPRAY DRIFT AT THE APPLICATION SITE IS THE RESPONSIBILITY OF THE APPLICATOR AND THE GROWER.

The interaction of many equipment and weather related factors determine the potential for spray drift. The applicator and the grower are responsible for considering all these factors when making decisions.

The following drift processing ament requirements must be followed to avoid off-target movement from aerial applications. These requirements do not apply to forestry applications, public health uses or to applications of dry materials.

Information on Dromlet Size

One of the most effective ways to reduce drift potential is to apply large droplets. The best shift management strategy is to apply the largest droplets that provide bufficient doverage for pesticide performance. Applying larger droplets reduces thift potential but will not prevent drift if applications are most conceptly or under unfavorable environmental conditions. (See information on Wind, Temperature and Humidity, and Temperature Inversion on Dibasenuent sections).

Controlling Spray Droptet Size

Volume – Use them tow rate prozets to apply the greatest practical spray volume. Note the math righer rated flow generally produce larger droplets

Pressure - When magnet mow rates are needed, use higher flow rate nozzles rather than homeasing spray pressure.

Nozzle Orientation in 1990 a population, the recommended practice is to depend pozzle in the single single single fractional minduces with the anstream with other nozzle orientations.

Significant nozzle deflection from horizontal will reduce droplet size and increase drift potential.

Nozzle Type - Use a nozzle type that is designed for the intended application. With most nozzle types, narrower spray angles produce larger droplets. Consider using low drift nozzles for both ground and aerial applications. Solid stream nozzles oriented straight back usually produce the largest droplets and the lowest drift potential in aerial applications.

Boom Length – For some aerial use patterns, reducing the effective boom length to less than ¾ of the wingspan or rotor length may further reduce drift without reducing swath width.

Application Height - Aerial applications should not be made at a height greater than 10 feet above the top of the target plant canopy unless a greater height is required for aircraft safety. Making applications at the lowest height that is safe reduces exposure of droplets to evaporation and wind.

Swath Adjustment – When aerial applications are made with a crosswind, the swath will be displaced downwind. Therefore, on the upwind and downwind edges of the field, the applicator must compensate for this displacement by the path of the aircraft upwind. Swath adjustment or offset distance should increase when conditions favor increased drift potential (higher winds, smaller droplets, etc).

Wind – Drift potential is lowest between wind speeds of 3-10 mph However, many factors, including droplet size and equipment type determine drift potential at any given wind speed. Application should be avoided below 3 mph due to variable wind direction and high inversion potential. NOTE: Local terrain can influence wind patterns. Every applicator should be familiar with local wind patterns and how they may potentially affect spray drift potential.

Temperature and Humidity – When making applications in low relative humidity, set up equipment to produce larger droplets to compensate for evaporation. Droplet evaporation is most severe when conditions are both hot and dry.

Temperature inversions – Applications should not occur during a temperature inversion because drift potential is high. Temperature inversions restrict vertical air mixing, which causes small-suspended droplets to remain in a concentrated cloud. This cloud can move in unpredictable directions due to the low speed and variable winds common during inversions. Temperature inversions are characterized by increasing temperatures with altitude and are common during conditions of limited cloud cover and little to no wind. They often begin to form as the sun sets and may often continue into the morning. The presence of a temperature inversions can also be identified by the movement of smoke from a ground source or an aircraft smoke generator. Smoke that remains in layers and moves laterally in a concentrated cloud (under low speed wind conditions) indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing

Sensitive Areas – The pesticide should only be applied when the wind is blowing away from sensitive areas (e.g. residential areas, bodies of water, known habitat for threatened or endangered species, non-target crops).

Off-Target Movement of Spartan DF

Drift of dilute spray mixtures containing. Spartan DF must be prevented. Observation of the preceding environmental conditions, correct application equipment design, calibration and application practices will significantly diminish the risk of off-target spray drift. Spartan DF can cause significant symptomology by drift on to sensitive crops and other plants. This symptomology may manifest initially as discreet, localized spots where contacted by Spartan DF drift mixtures. Depending on concentration of the spray solution and droplets size (effectively determining the dosage of sulfentrazone) and also depending on the inherent sensitivity of the plants involved, these spots or lesions may or may not coalesce. These effects will usually not have lasting effects on plant growth but will likely reduce the value of affected fruit or foliage where grade or quality is associated with appearance. In severe drift instances with particularly sensitive crops, defoliation of affected foliage could result. Failure to follow these guidelines and environmental prohibitions that then result in off-target movement or drift of Spartan DF on to unintended crops or plants, irrespective of severity, constitutes. misapplication of this product. FMC accepts no responsibility or flability for potential crop effects that may result from such misapplication of Spartan CF

GENERAL APPLICATION INSTRUCTIONS

Spartan DF may be applied to soil as a preplant incorporated treatment or as a pre-emergence (to weed and crop) surface application. Additional application methods include post-plant treatments, over-the-top and layby, in various crops. Application methods are defined in the following Crop Use Directions sections.

Preplant incorporated treatments require a uniform surface application followed by incorporation to a depth no greater than 2 inches. Care must taken not to create overlaps in treated zones due to soil movement which will result in excessive. Spartan DF rates that could result in adverse crop response. Additional care must be exercised to prevent deep incorporation of Spartan DF which may result in poor weed control performance on shallow germinating weeds

All soil applications and the residual activity of post-plant applications of Spartan DF require adequate moisture for herbicidal activation. The ultimate amount of moisture, whether supplied by rainfall or irrigation, is dependent on several factors. These factors include but are not limited to existing soil moisture at application, soil type, organic matter and tilth. In crop situations dependent on rainfall. Spartan DF can await activating moisture for extended periods (10 to 14 days or longer) depending on the soil parameters described above. Once activated, Spartan DF will provide activity on existing weeds. The level of activity will depend on the weed species and their size at time of activation. Where irrigation is not available and cainfall has not provided activation, particularly for surface

applications of Spartan DF, a shallow incorporation is recommended for destruction of any germinating weeds and to incorporate Spartan DF. Herbicide incorporation will initiate the process of activation with existing soil moisture. In circumstances where prolonged periods without rainfall or irrigation are not possible, alternative or additional weed management practices (cultivation or post-applied herbicides) may be required.

Extreme care must be exercised and the Crop Specific Use Directions followed exactly in crops allowing post plant applications of Spartan DF. Over-the-top and lay-by applications will provide contact and residual weed control, depending on species. The addition of surfactants may increase contact weed control performance but may also increase the risk of adverse crop response as well.

GENERAL SPARTAN DF PRODUCT USE RATES

The following directions for the selection of Spartan DF application rates are critical to achieve maximum performance and to insure maximum crop safety. Mode of Action

Sulfentrazone, the active ingredient in Spartan DF, is a potent inhibitor of the enzyme Protoporpyrinogen Oxidase IX (PPO IX) required for the formation of chlorophyll. Inhibition of PPO IX enzyme results in the liberation of singlet oxygen (O) that, in turn, disrupts cellular membranes and causes cellular leakage. The ultimate manifestation of the process is cellular death leading to plant death. The selective herbicidal activity of sulfentrazone is based on its greater affinity for the PPO IX enzyme in weed species versus crop plants. Mechanism of Action

Following the application of Spartan DF to soil, germinating seeds and seedlings take up suffentrazone from the soil solution. The amount of suffentrazone in soil solution, and available for weed uptake, is determined primarily by soil type, organic matter and soil pH. Sulfentrazone adsorbs to the clay and organic matter (OM) fractions of soils, effectively limiting the amount of active ingredient immediately available to control weeds. Influence of Soil type, organic matter and pH on Spartan Use Rates and Crop Response - a spin to the second

Soil organic matter content can vary widely and independently of soil type and requires an accurate analysis of representative soil samples to determine its content.

Soil pH also exerts a dramatic affect on sulfentrazone availability in the soil solution. As soil pH increases, sulfentrazone availability increases. Soil pH also requires an accurate analysis of representative soil samples.

The total amount of sulfentrazone available in solution, in any given soil, is determined by the interaction of soil type (clay content), % organic matter and pH. The application timing(relative to the emergence of the crop and weeds) and amount of rainfall and/or irrigation received will ultimately determine, in conjunction with the soil parameters and pH, the amount of sulfentrazone in soil solution. SPRAY TANK PREPARATION

It is important that spray equipment is clean and free of existing pesticide deposits before preparing Spartan spray mixtures. Follow the spray tank clean out procedures specified on the label of the product or products previously applied.

MIXING INSTRUCTIONS

Spartan DF may be tank mixed with other herbicides for the control of additional weed species. Mixtures with some other pesticides have not been tested. Conduct appropriate compatibility tests prior to tank mixing with other pesticides. Follow all precautions and restrictions on the tank mix partner label.

For best results fill spray tank with one half of the volume of clean water needed for the field to be treated. Start aditation system. Prepare a slurry of Spartan DF in a clean container using clean water. Slowly add the Spartan/water slurry to the spray tank. Carefully rinse the slurry container, adding the rinsate to the spray tank. Complete filling the spray tank to the desired level. Continuous spray tank agitation is required at all times to maintain a uniform spray solution. Make sure Spartan is thoroughly mixed before application or before adding another product to the spray tank.

Use the Spartan spray mixture immediately after mixing. Do not store the sprayer overnight or for any extended period of time with the Spartan spray mixture remaining in the tank. Premixing Spartan spray solutions in nurse tanks is not recommended.

If Spartan is tank mixed with other herbicides, all additional directions, restrictions and precautions for the tank mixture herbicides must be followed.

SPRAYER EQUIPMENT CLEAN OUT

After spraying Spartan and before using sprayer equipment for any other applications, the sprayer must be thoroughly cleaned to avoid potential crop affects using the following procedure.

1. Drain sprayer tank, hoses, and spray boom. Use a high-pressure datergent wash to remove physical sediment and residues from the inside of the sprayer tank and thoroughly rinse. Thoroughly flush sprayer hoses, booms and nozzles with clean water.

2. Fill the tank 1/2 full with clean water, and add appropriate detergent or ammonia (follow manufacturer's directions for use). Fill the tank to sufficient capacity to operate the sprayer for 15 minutes to flush hoses, booms, and nozzles.

3. Drain the sprayer system. Rinse the tank with clean water and flush through the hoses, boom, and nozzles. Remove and clean spray tips and all strainers and screens separately.

4. Properly dispose of all cleaning solution and rinsate in accordance with Federal, State and local regulations and guidelines.

5. Do not drain or flush equipment on or near desirable trees or plants. Do not contaminate any body of water including irrigation water that may be used on other crops.

APPLICATION WITH DRY FERTILIZERS

Spartan DF may be applied impregnated on dry fertilizers. When applied as directed with adequate soil coverage. Spartan dry bulk fertilizer mixtures will provide satisfactory weed control, but adequate soil coverage is essential.

Follow all Spartan label directions regarding product use rates per acre, registered crops, incorporation, special instructions and precautions. Apply Spanan/dry fertilizer mixtures with ground equipment only.

All individual state regulations relating to dry bulk fertilizer blending, registration, labeling, and application are the responsibility of the individual and /or company preparing, storing, transporting, selling or applying the Spartan/dry fertilizer mixture.

A minimum of 200 pounds of dry bulk fertilizer impregnated with the recommended amount of Spartan must be applied per acre to achieve adequate soil cover togation satisfactory weed control.

DO NOT impregnate Spartan onto coated ammonium nitrate or limestone because these materials will not absorb the herbicide.

Refer to the appropriate crop section of the Spartan label to determine the rate of Spartan to be applied per acre. IMPREGNATION DIRECTIONS

To impregnate Spartan DF on dry bulk fertilizer, use a closed rotarydrum mixer or other commonly used dry bulk fertilizer blender equipped with suitable spray equipment.

Prepare a slurry of Spartan DF in a clean container using clear water. Slowly add the Spartan/water slurry to the impregnation spray tank and finish filling as needed with clear water. Spray nozzles must be placed to provide uniform coverage of Spartan onto the fertilizer during mixing.

Refer to the SPRAYER EQUIPMENT CLEAN-OUT section for directions for cleaning impredibation equipment.

Apply the Spartan DF dry bulk fertilizer with an accurately calibrated dry fertilizer spreader. The Spartan DF dry bulk fertilizer mixture must be spread uniformly on the soil surface. Uneven spreading leaving untreated areas can cause poor weed control or overlapping areas with potential increased. Spartan DF use rates could result in possible crop response.

APPLICATION WITH LIQUID FERTILIZERS

Spartan DF may be applied using liquid fertilizer solutions as the carrier. The fertilizer solutions may either be concentrate formulations as blended or diluted auto water. When applied as directed with adequate soil coverage. Spartan DF applied with liquid fertilizer mixtures will provide satisfactory weed control. However, adequate soil coverage is essential to achieve acceptable levels of weed control.

Herbicide mixing, solution stability and/or compatibility problems can occur when liquid fertilizers are used as a carrier. Compatibility tests must be conducted order to mixing to insure tank mixture compatibility and stability. The use of compatibility agents may be beneficial to achieve and maintain a company solution.

Mixing Instructions

Fill the clean spray table to one half of the total volume with the fertilizer solution. Start the scraw tank agitation system. Prepare a slurry of Spartan DF in a clean container with clean water using equal volumes of Spartan DF and choice water. Slowly add the Spartan/water slurry to the spray tank. Carettake the slurry container, adding the rinsate to the spray tank. Better a complete the Spartan DF/water slurry may be achieved if the start is could using induction systems on the sprayer fill plumbing system.

Complete filling the spray tank to the desired level. Sufficient and continuous spray tank agitation is required at all times to maintain a homogenous spray solution. The spray system must be designed such that there is sufficient flow capacity to uniformly apply the spray mixture and maintain adequate tank agitation. Some systems may require separate pumps to simultaneously supply the spray system and the spray tank agitation system. Insure the Spartan DF slurry is thoroughly mixed before application.

For tank mixtures with other herbicide(s), a compatibility test must be conducted to insure product compatibility before mixing. Read and follow all the directions, precautions and restrictions of the tank mixture products prior to mixing.

Apply the Spartan DF spray mixture immediately after mixing. Do not store the sprayer overnight or for any extended period of time with the Spartan DF spray mixture remaining in the tank.

Premixing Spartan DF spray solutions in nurse tanks is not recommended.

Follow all Spartan DF label directions regarding product use rates per acre, registered crops, application instructions, incorporation directions, special instructions and all precautions.

All individual state regulations relating to liquid fertilizer blending, storage, transportation, registration, labeling, and application are the responsibility of the individual and/or company preparing, selfing or applying the Spartan DF and fertilizer mixture.

WEEDS CONTROLLED

The overall spectrum of weed performance of Spartan DF is provided in Table 6. This table reflects. Spartan DF activity based on extensive field performance testing in numerous crops. It is categorized into two levels of economic herbicide performance. Control (>85%) and Partial Control (71 to 84%) When applied in accordance with the previous General Application Instructions and the Crop Specific Use directions below. Spartan DF activity will perform as described in Table 6. Specific key economic weeds controlled by Spartan DF are presented in each Crop Specific Use recommendation as well. It is important to note that certain exceptions to the overall weed performance occur under various circumstances. These exceptions are noted, by weed species, in the Crop Specific Use directions when they are recognized to occur. In such cases additional or alternative weed management maybe required for these weed species. FMC accepts no responsibility or liability for potential reduction or failure of weed control performance resulting from the failure to observe this weed spectrum and the noted exceptions in the Crop Specific Use directions.

Preplant (Fall Applications)

Spartan DF may be applied in the fall as a preplant treatment prior to corn planting the following spring.

Spartan DF can be used alone or in a tank mixture with other herbicides to control susceptible broadleaves, sedges and grasses in corn. Apply Spartan DF on conventional tillage or conservation tillage (reduced tillage or no-tillage) cropping systems using rates recommended in the Table 7. Spartan DF should be applied to the stubble or soil surface and allow moisture from rainfall or snow to move the product into the soil. Do not mechanically incorporate in the fall or spring as this operation can destroy the herbicide barrier allowing weed escapes to occur. Do not apply to frozen soils or existing snow cover to prevent. Spartan DF runoff from rain or snowmelt that may occur following application. Spartan DF may be tankmixed with other burndown herbicides to control emerged weeds in the fall or residual soil herbicides that are labeled for fall use on Select the correct Spartan DF corn use rate from the Table 7 for corn. your soil type and organic matter. Due to the extended period of time between the fall application and corn planting, the use rate of Spartan DF should be the mid to high rate within the rate range for the appropriate soil type and organic matter.

Early Preplant and Preemergence (Spring Applications)

Spartan DF may be applied preplant on the soil surface in the spring to control weeds in conventional and conservation tillage systems. Spartan DF can be applied from 45 days prior to planting until 3 days after planting as a preemergence broadcast or banded soil application if corn seedlings have not broken the soil surface and if the seed furrow is completely closed. Preplant Incorporated

Spartan DF may be applied as a Preplant Incorporated treatment in the spring prior to planting in reduced and conventional tillage corn. Spartan DF should be shallowly incorporated or mixed thoroughly into the soil to a maximum depth of 2 inches using a correctly adjusted implement such as a field cultivator, field finisher or disk harrow. Incorporating Spartan DF deeper than 2 inches may result in inconsistent weed control. Use the appropriate rate from Table 7 for the soil texture, organic matter, and pH level of the soil. Spartan DF can be tankmixed with other soil-applied herbicides and insecticides labeled for preplant incorporation in corn. Ground and Aerial Applications

Apply Spartan DF as a by aerial application, preemergence treatment following planting and after dragoff, but prior to potato emergence. Optimum performance can be achieved if Spartan DF is applied to the soil surface and either rainfall or overhead irrigation is used to activate the product. If no moisture is received within 7 days following application in areas without irrigation, a shallow incorporation(less than 2 inches) may be needed prior to weed and potato emergence to activate the product. Ground and Aerial Applications

Apply Spartan DF in conventional tillage, conservation tillage, reduced tillage or no-tillage cropping systems using rates recommended in the Spartan DF. Use Rate Table 11. Spartan DF may be with ground or aerial sprayers calibrated to deliver a minimum of 10 gallons of finished spray by ground application and 5 gallons of finished spray by air. Early Preplant and Fall Applications (For use in ND, SD, MT, MN, WY, CO, NE, KS)

Spartan DF may be applied in the fall as a preplant treatment to control or suppress weeds prior to planting sunflowers the following spring. Spartan DF should be applied to the stubble or soil surface and allow moisture from rainfall or snow to move the product into the soil. Do not mechanically incorporate in the fall or spring as this can destroy the herbicide barrier and weed escapes can occur. Do not apply to frozen soils or to existing snow cover to prevent.
