<sup>1</sup>Deer ticks (*Ixodes sp.*) have a complicated life cycle that ranges over a two year period and involves four life stages. Applications should be made in mid to late-spring to control larvae and nymphs that reside in the soil and leaf litter.

<sup>2</sup>Imported Fire ants: Control will be optimized by combining broadcast applications that will control foraging workers and newly mated fly-in queens with mound treatments (using Talstar GC Flowable) that will eliminate existing colonies.

<sup>3</sup>The higher application rate may be required to control Ants, Centipedes, Fleas, Imported Fire Ants, Millipedes, Mole Crickets & Ticks (including Deer Ticks).

In New York State, this product may NOT be applied to any grass or turf area within 100 feet of a water body (lake, pond, river, stream, wetland, or drainage ditch).

In New York State, do make a single repeat application of Talstar® 0.073 GCGURR Granular Insecticide with Fertilizer if there are signs of renewed insect activity, but not sooner than two weeks after the first application.



FMC is interested in revising labeling for the subject product. Specifically, the following changes have been made:

- Change "Guaranteed Analysis" for fertilizers from a specific number (19-0-19) to "X-X-X". This would allow us to use any blend of fertilizer components without having to file a new label each time. We have an amendment pending currently that amends the Confidential Statement of Formula to make this same change. This was a minor formulation amendment submitted August 3, 2004.
- Change to brand name to reflect the change to X-X-X.


