

Use of Adjuvants: In some situations where coverage is difficult to achieve due to a closed canopy, dense foliage, or less than optimum application conditions and/or application equipment, an adjuvant may improve performance. If adjuvants are used, the following guidelines should be followed:

-Use only adjuvant products labeled for agricultural use and follow directions on the manufacturer's label. A nominal concentration of 1 to 2 qt/100 gal (0.25 to 0.5% v/v) is generally stifficient.

-Use only emulsified crop oil, methylated crop oil plus organosilicone combination products or nonionic surfactants.

Application

Proper application techniques help ensure thorough spray coverage and correct dosage necessary to obtain opt-num control of insect pests. The following recommendations are provided for ground and aerial application of Double Threa:

Ground Application

Apply in a minimum spray volume of 5 gallons of water per acre. Use ground spray equipment operated to deliver thorough coverage of the target crop. Follow manufacturer's recommendations for proper nozzle spacing and spray pressure and boom height for optimum spray deposition, and to minimize spray drift. Spray Drift Precautions

All aerial and ground application equipment must be properly maintained and calibrated using appropriate carriers. OBSERVE THE FOLLOWING PRECAUTIONS WHEN SPRAYING IN THE VICINITY OF AQUATIC AREAS SUCH AS LAKES; RESERVOIRS; RIVERS; PERMANENT STREAMS, MARSHES OR NATURAL PONDS; ESTUARIES AND COMMERCIAL FISH FARM PONDS. Spray should be released at the lowest height consistent with pest control and flight safety. Applications more than 10 feet above the crop canopy should be avoided.

Make aerial or ground applications when the wind velocity favors on target product deposition (approximately 3 to 10 mph). Do not apply when wind velocity exceeds 15 mph. Avoid applications when wind gusts approach 15 mph.

Risk of exposure to sensitive aquatic areas can be reduced by avoiding applications when wind direction is toward the aquatic area. Do not cultivate within 10 feet of the aquatic area so as to allow growth of a vegetative filter ship.

Low humidity and high temperatures increase the evaporation rate of spray droplets and therefore the likelihood of increased spray drift to aquatic areas. Avoid spraying during conditions of low humidity and/or high temperature.


