Notification Label Amendment

FMC is interested in amending the label for the subject registration by notification. FMC believes that these changes are in full compliance with the requirements outlined in the June 4, 2009 letter from Richard Gebkin, "Re: Environmental Hazard and General Labeling for Pyrethroid Non-Agricultural Outdoor Products Notification." No other changes have been made to this label. We are making the following changes:

- a) Revised the Environmental Hazards statement to add: To protect the environment, do
 not allow pesticide to enter or run off into storm drains, drainage ditches, gutters or
 surface waters. Applying this product in calm weather when rain is not predicted for the
 next 24 hours will help to ensure that wind or rain does not blow or wash pesticide off the
 treatment area.
- b) Revised the Outdoor Use statement to add: All outdoor applications must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:
 - (1) Treatment to soil or vegetation around structures;
 - (2) Applications to lawns, turf, and other vegetation;

(3) Applications to building foundations, up to a maximum height of 3 feet.

Other than applications to building foundations, all outdoor applications to impervious surfaces such as sidewalks, driveways, patios, porches and structural surfaces (such as windows, doors, and eaves) are limited to spot and crack-and-crevice applications, only.

Pay particular attention to cracks and crevices; service ducts; false floors and ceilings; wall voids; around electrical and telephone fittings and equipment; around water and sewer pipes; under and behind cabinets; refrigerators and sinks; around windows and doorframes; along baseboards; in attics and crawispaces. The amount to be applied will vary with the site but should usually be in the range of 0.05 to 0.07 ounces per square yard (1.58 to 2.4 grams per square meter or 0.32 to 0.5 pounds per 1,000 square feet).

For indoor/outdoor uses: Repeat application only if there are signs of renewed insect activity. Repeat application should be limited to no more than once per 7 days.

INDOOR USE

Use this product to kill ants (including Imported Fire Ants), bedbugs, boxelder bugs, carpet beetles, centipedes, cockroaches, crickets, earwigs, firebrats, fleas, ground beetles, millipedes, silverfish, slugs, sow bugs, spiders (except black widow and brown recluse sprders), springtails, termites and wasps (except paper wasps), and webbing clothes moths.

Food Handling Establishments: Places other than private residences in which food is held, processed, prepared or served. Applications are permitted as a spot or crack and crevice treatment.

Nonfood Areas: Includes garbage rooms, lavatories, floor drains, (to sewers) entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets, and storage (after canning or bottling). *Cynoff insecticide* may be used as a general spot, crack and crevice treatment in nonfood areas. All areas where insects inhabit or through which insects may enter should be treated.

Food Areas: Do not use in food/feed areas of food handling establishments, restaurants or other areas where food is commercially

Make applications in a manner to avoid deposits on exposed surfaces on introducing the excess material into the air.

Void Treatments

This product may also be applied as a void treatment using suitable equipment, including Actisol® DPA equipment. Be sure to thoroughly treat service ducts, false floors and ceilings, wall voids, attics and crawl spaces. The amount of dust to be applied will vary with the site but should usually be in the range of 0.05 to 0.07 ounces per square yard (1.58 to 2.4 grams per square meter or 0.32 to 0.5 pounds per 1,000 square feet).

Ants, boxelder bugs, cockroaches, crickets, fleas, firebrats, and silverfish: Apply Cynoff insecticide thoroughly to all areas where these pests crawl and hide, especially in those areas described above. For ants, apply to ant trails, around doors and windows and other places where ants enter the premises.

Termites, carpenter ants and carpenter bees:

Apply to voids or channels in damaged wooden members of a structure; to cracks, spaces or bearing joints between wooden members of a structure; or between such members and the foundation; and in locations vulnerable to termite attack. Drilling may be necessary prior to applying *Cynoff Insecticide* in these locations, but it must be recognized that such drilling and treating of timber in a particular location may not result in complete coverage of infested and vulnerable voids or galleries. Drilling directly overhead with subsequent application of *Cynoff Insecticide* should be avoided. This product is intended to kill workers and/or winged reproductive forms of termites present at the time of application only. Application of this product will not provide structural protection nor substitute for mechanical alteration, soil or foundation treatment with termites, as it is not intended for use for elimination of termite infestations nor for protection against future infestations. A professional inspection is recommended.

Centipedes, ground beetles, millipedes, spiders (except black widow and brown recluse spiders) and sow bugs: Apply *Cynoff Insecticide* along and behind baseboards, to window and door frames, corners, pipes, storage locations, attics, crawl spaces, and other areas into which these pests may enter or crawl.

Bees and Wasps (except paper wasps): It is generally advisable to treat bee and wasp nests in the evening when insects are less active and have returned to the nest. Wear protective clothing if deemed necessary to avoid stings. Using hand or power duster (Actisol® or similar equipment) or other suitable means, with extension tubes if necessary, thoroughly dust nest, entrance and surrounding areas where insects alight. For ground wasps, dust entrance and surrounding areas.

Webbing clothes moths: Use Cynoff Insecticide as a crack and crevice treatment in closets and other storage areas where these pests are found. This is an adjunct treatment and will not control moth larvae already on the clothes. DO NOT apply this product directly to clothing.

Carpet beetles (black, furniture, common and varied):

Dust where these insects are found, for example: on and under edges of floor coverings, around baseboards, under rugs and furniture, and in closets.

Bedbugs: Apply 0.05 to 0.07 ounces of *Cynoff* per square yard (1.58 to 2.4 grams per square meter) to cracks and crevices where evidence of bed bugs occurs. This includes bed frames, box springs, inside empty dressers and clothes closets and carpet edges, high and low wall moldings and wallpaper edges. Do not use this product on mattresses, pillows, bed linens, or clothes. Remove all clothes and other articles from dressers or clothes closets before application. Allow all treated areas to dry thoroughly before use. Not recommended for use as sole

(1) Treatment to soil or vegetqation around structures;
(2) Application to lawns, turf, and other vegetation;

Telecommunication Treatment: this Apply product into telecommunication conduits, cracks and crevices, junction boxes, etc. using suitable application equipment (such as Actisol® DPA Duster, or other types of application equipment capable of applying the proper amount). Repeat application only if there are signs of renewed insect activity. This product is intended to kill workers and/or winged reproductive forms of termites present at the time of application only. Application of this product will not provide structural protection nor substitute for mechanical alteration, soil or foundation treatment with termiticide. This product is not to be used as sole protection against termites, as it is not intended for use for elimination of termite infestations nor for protection against future infestations. A professional inspection is recommended.

Arboreal Ants: Ants inhabiting trees or tree stumps may be treated by injecting dust directly into the opening in the tree used by foraging ants or by drilling holes in the tree for the injection of dust into voids within the tree.

Ornamental Plant Pests: aphids, beet armyworms, blister beetles, boxelder bugs, elm leaf beetle, flea beetles, Japanese beetles, leafhoppers, leafminers (Boxwood, Holly, Oak,

Spruce Needle), leafrollers, orange tortrix, periodical cicada, plant bugs, rose chafer, rose midges, tent caterpillars, thrips, and weevils. Shrubs and Ornamentals: Apply when insects or their damage

first appear and repeat at weekly intervals or as necessary. Apply 0.32 to 0.5 pounds per 1000 square feet; or thoroughly apply a thin layer of dust on both upper and lower sides of leaves, stems and flowers.

Roses, petunias, chrysanthemums, geraniums, carnations and other related flowers: Apply as soon as the insect appears and repeat at 7 day intervals or as long as insects continue to appear. Apply a thin layer of dust on both upper and lower sides of leaves, stems and flowers.

Sewer Treatment: Cockroach infestations in sanitary sewers may be treated with *Cynoff Insecticide* to provide quick knockdown and short-term population suppression.
