On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Based on the above toxicity profile please change the signal word to "WARNING" and revise the Precautionary Statements to read as follows:

"May be fatal if swallowed. Harmful if inhaled or absorbed through skin. Avoid contact with skin, eyes or clothing. Avoid breathing dust. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove and wash contaminated clothing before reuse."

Note according to PR Notice 2001-2 the acute toxicity data referenced above was bridged to support registration of this product. However according to the Notice the Agency cannot bridge down from toxicity categories of I or II for the source product. If you want the product classified in a lower toxicity category (III or IV) you will need to submit your own acute toxicity studies on this formulation or cite data on a substantially similar product. Enclosed for your information is a copy of the Precautionary Label review.

- c) Revise the front panel statement to read, "To be used in the production of plastic films in contact with bananas for importation only."
- 3. Submit an one year storage stability study for the proposed product under warehouse conditions along with a corrosion characteristics study. We recommended that observation be made at 0, 3, 6, 9, and 12 months intervals in the storage stability study.
- 4. Please submit two (2) copies of your final printed label for before your release the product for shipment. Please refer to the A-79 enclosure for a further description of final printed labeling. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.
