Environmental Hazards

This pesticide is toxic to marine/estuarine invertebrates. Do not apply directly to water, to areas where surface water is present or to intertidal areas below the mean high water mark. Drift and runoff may be hazardous to terrestrial and aquatic plants in neighboring areas. Do not contaminate water when disposing of equipment wash waters or rinsate.

Non-Agricultural Use Requirements

Re-entry Statement: Do not allow people (other than applicator) or pets on treatment area during application. Do not enter treatment area until dust has settled.

STORAGE AND DISPOSAL

Do not contaminate water, food of feed by storage or disposal.

Pesticide Storage: Store product in original container only, away from other pesticides, fertilizer, food or feed. Reseal open bag by folding top down and securing. Store in a cool, dry place and avoid excess heat.

Spill: In case of spill, avoid contact, isolate area and keep out animals and unprotected persons. Confine spills. Call FMC: (800) 331-3148.

General Information

Turf Use Instructions

Echelon is a selective pre-emergence and post-emergence turf herbicide for control of sedges, annual grass and broadleaf weeds in turf sites including residential and institutional lawns, athletic fields, commercial sod farms, golf course fairways and roughs.

Echelon turf herbicide is formulated as a herbicide on a granule carrier containing 0.9 % active ingredient per pound of carrier. The mode of action of Echelon turf herbicide involves uptake by both weed roots and shoots of existing weeds and prevention of growth by newly emerged weed seedlings.

Turf Application: Broadcast Echelon 0.9% Granular Herbicide with suitable application equipment to ensure uniform coverage over the treatment area. A drop or rotary spreader designed to apply granular fertilizer, herbicide or insecticide is the preferred application of this product. Calibrate application equipment prior to application. Consult applicators manufacturer's operation manual for proper calibration and operation. Apply 0.643 to 2.9 pounds per 1,000 square feet to control broadleaf weeds and grasses (see Table 1 for application rates based on turf grasses).

Weed Control in Turfgrasses Use Precautions for Turf Use Turfgrass Safety

This product may be used on seeded, sodded or sprigged turgrasses that are well established. First application of this product can be made following the second mowing providing the grass has developed into a uniform stand with a good root system. Turf injury could result from application of this product on turf that is not well established or has been weakened by stresses such as unfavorable weather conditions, disease, clemical or mechanical influences.

When applied as directed under the conditions described, the following established grasses are tolerant to Echelon at the recommended use rates in a range from 0.259

to 1.125 lb a.i./acre (28 to 125 lbs/acre or 0.643 to 2.9 lbs./1,000 sq. ft). Do not exceed 1.125 lbs a.i./acre (125 lbs of product) rate per calendar year.

- 2. Apply Echelon in late summer, fall or winter before weed germinates for control.
- 3. Crabgrass control in cool season grasses from fall application:

 Areas where the ground is subject to winter freezes, Echelon may be applied in the fall at rates in listed in Table 1 for cool season grasses when soil temperatures are below 50F, but prior to the ground freezing. This will provide control of crabgrass the following spring.
- 4. In areas of extended growing season and heavy pressure weed control will be enhanced by second application of Echelon 60 -90 days after initial application

Postemergence Control of Annual, Biennial & Perennial Broadleaf Weeds and sedges

ECHELON herbicide will control or suppress the weeds listed in Table 3 when applied shortly after weeds have emerged. Do not exceed the application rate specified for the turf species in Table 1.

Sod Production:

It is recommended that sod be established for at least six (6) months before an application of Dismiss turf herbicide.

Do not apply this product within three (3) months of harvest.

Do not apply to golf course putting greens or tees.
