Resistance Management Recommendations:

F6133 G Insecticide contains Group 3 Insecticides. Insects with acquired resistance to Group 3 Insecticides may eventually dominate the insect population if Group 3 Insecticides are used repeatedly in successive years as the primary method of control for targeted species. This may result in partial or total loss of control of those species by F 6133 G Insecticide or other Group 3 Insecticides.

In New York State, this product may NOT be applied to any grass or turf area within 100 feet of a water body (lake, pond, river, stream, wetland, or drainage ditch). In New York State, do make a single repeat application of F6133 G if there are signs of renewed insect activity, but not sooner than two weeks after the first application.

SPECIFIC PEST INSTRUCTIONS

For optimum control of particular pests, follow procedures outlined below:

Armyworms, Cutworms, and Sod Webworms: To ensure optimum control, irrigate the treated area with water immediately after application to activate (release from the granule) the insecticide.

Annual Bluegrass Weevil (Hyperodes) adults: Applications should be timed to control adult weevils as they leave their overwintering sites and move into grass areas. This movement generally begins when Forsythia is in full bloom and concludes when flowering dogwood is in full bloom. Consult your State Cooperative Extension Service for more specific information regarding application timing.

Billbug adults: Applications should be made when adult billbugs are first observed during April and May. Degree day models have been developed to optimize application timing. Consult your State Cooperative Extension Service for information specific to your region. In temperate regions, spring applications targeting billbug adults will also provide control of over-wintered chinch bugs.

Chinch Bugs: Chinch bugs intest the loase of grass plants and are often found in the thatch layer. Irrigate the treated area with up to 0.25 inches of water immediately after application to activate (release from the granule) the insecticide. Chinch bugs can be one of the most difficult pests to control in grasses and the higher applications rates may be required to control populations that contain both nymphs and adults during the surfamer [

Crane Flies: Treatments should be made to control early to midseason larvae (approximately August – February) as they feed on plant crowns. Treatments made to late-season larvae (approximately March - April) may only provide suppression. Consult your local extensions agent for specific recommendations for your

Fleas (adults and larvae): Control is provided for up to seven days. Flea larvae develop in the soil of shaded areas that are accessible to pets or other animals. Irrigate the treated area with up to 0.5 inches of water immediately after application to activate (release from the granule) the insecticide.

This product is designed for use as a ready-to-use granular insecticide to control imported Fire Ants. This product can be used as a broadcast or mound treatment to prevent imported fire ants from establishing populations and/or to control existing populations.

WHERE TO USE:

On Lawns, Ornamentals, Flowers, Home Foundations [Perimeter]

FOR BROADCAST TREATMENT

HOW TO USE:

Apply during the morning or late evening when it is cool and the ants are most active. Treat the entire lawn area to prevent reinfestation of fire ants from neighboring areas using broadcast or drop spreader. For best control of foraging workers and newly mated flyin queens, use both broadcast applications and mound treatments that will kill exisiting colonies.

Control will be optimized by combining broadcast applications that will control foraging workers and newly mated fly-in queens with mound treatments that will control existing colonies.

[For residential use only. Not for use in pasture or animal (livestock)

grazing areas.]

HOW TO APPLY:Apply uniformly over your lawn using the suggested spreader settings. Measure your treatment area to calculate the square feet (Length x Width of lawn area) and evenly distribute the product across the entire area. immediately after application. Water-in area

FOR MOUND TREATMENT:

HOW TO USE

Make applications in the early morning or late evening hours when it is cool and the ants are most active. Apply when temperatures are between 65 and 80 F.

HOW TO APPLY

Treat mound and an area 4 ft in diameter around the mound. Apply 1/2 cup of product over each fire ant mound. Irrigate the soil before application if it is dry. After application, apply 1 to 2 gallons of water over each mound. Treat mounds with sufficient force to break their apex and allow the insecticide solution to flow into the ant tunnels, but not enough to significantly damage the mound which may lead to relocation. This treatment will control the mound within 15 [fifteen] minutes and kill the queen within 24 hours of application.

FOR MOUND DRENCH TREATMENT:

HOW TO USE

Make applications in the early morning or late evening hours when it is cool and the ants are most active. Apply when temperatures are between 65 and 80 F.

HOW TO APPLY

Dilute 1 teaspoon of this product per 1 gallon of water. Apply 1 to 2 gallons of diluted spray per mound. Treat mounds with sufficient force to break their apex and allow the insecticide solution to flow into the ant tunnels, but not enough to significantly damage the mound which may lead to relocation. This treatment will control the mound within fifteen minutes and kill the queen within 24 hours of

NOTE: Do not use food utensils, such as teaspoons and measuring cups, for food purposes after use with pesticides.

Mole Cricket adults: Achieving acceptable control of adult mole crickets is difficult because preferred grass areas are subject to continuous invasion during the early spring by this extremely active stage. Applications should be made as late in the day as possible and should be watered in with up to 0.5 inches of water immediately after treatment. If the soil is not moist, then it is important to irrigate before application to bring the mole crickets closer to the soil surface where contact with the insecticide will be maximized. Grass areas that receive pressure from adult mole crickets should be treated at peak egg hatch to ensure optimum control of subsequent nymph populations (see below).

Mole Cricket nymphs: Grass areas that received intense adult mole cricket pressure in the spring should be treated immediately prior to peak egg hatch. Optimal control is achieved at this time because young nymphs are more susceptible to insecticides and they are located near the soil surface where the insecticide is most concentrated. Control of larger, more damaging, nymphs later in the year may require both higher application rates and more frequent applications to maintain acceptable control. Applications should be made as late in the day as possible and should be watered in with up to 0.5 inches of water immediately after treatment. If the soil is

not moist, then it is important to irrigate before application to bring the mole crickets closer to the soil surface where contact with the insecticide will be maximized.

Scorpions: To ensure optimum control, treat the building perimeter at dusk to prevent outdoor scorpions from entering the building. Scorpions reside hidden in cracks and voids during the day and are active at night at temperatures above 77°F/25°C. Resting areas can be identified at night using a blacklight (UV bulb) as scorpions will fluoresce. These areas should also be treated. Prior to treatment, to increase treatment efficacy, remove trash, debris, or firewood that scorpions may use as resting sites.

Ticks (Including ticks that may transmit Lyme Disease and Rocky Mountain Spotted fever): Do not make spot applications. Treat the entire area where exposure to ticks may occur. Use higher application rates when treating areas with dense ground cover or heavy leaf litter. Ticks may be reintroduced from surrounding areas on host animals. Do not allow public use of treated areas during application.

Deer ticks (Ixodes sp.) have a complicated life cycle that ranges over a two year period and involves four life stages. Applications should be made in mid to late-spring to control larvae and nymphs that reside in the soil and leaf litter.

American dog ticks may be a considerable nuisance in suburban settings, particularly where homes are built on land that was previously field or forest. These ticks commonly congregate along paths or roadways where humans are likely to be encountered. Applications should be made as necessary from mid-spring to early fall to control American dog tick larvae, nymphs and adults.

INDUSTRIAL NON-AGRICULTURAL **APPLICATIONS**

(Including Industrial Sites, Parks, Ball Fields and Cemeteries)

Broadcast Spot Treatment: For the control of actively foraging ants (including Imported Fire Ants) broadcast uniformly 2.3 lbs to 4.6 lbs F6133 G insecticide per 1000 sq. ft.

Pad Mounted Electrical Sites: To reduce or prevent ant mound building activity on electrical pads, uniformly distribute 1.0 to 1.5 Tablespoons of F6133 G insecticide per 4 sq. ft. of mounting pad. Where existing transformers are completely or partially filled with soil excavated by resident ants, remove any excess fill and level the remaining soil prior to application. For best results treat in the Fall or early Spring. Food utensils such as tablespoons must not be used for food purposes after use in measuring pesticides.

Note: Electrical transformers appear to be more attractive to ants during the cooler months. For best results treat in the Fall or early Spring.

SPREADER EQUIPMENT SETTINGS

Broadcast application should be performed with a calibrated commercial broadcast spreader to evenly distribute the granules. Approximate settings for several models are provided in the table
