## PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS & DOMESTIC ANIMALS CAUTION

Harmful if swallowed. Causes eye irritation. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling.

#### **FIRST AID**

#### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Apply and place liquid bait only in areas inaccessible to children and pets.

INDOORS: Apply liquid bait indoors in areas where ants are seen. Apply behind and under the following: stoves, refrigerators, dishwashers, sinks, counters, shelving, tubs, waterpipes, around drains, sewers, electrical boxes, windowframes, baseboards and shelves. Renew as needed.

OUTDOORS: Where ants are seen entering the building place liquid bait along walkways, sidewalks, directly on ant nests and along window and doorsills. Renew as needed.

Food Areas: (Restaurants, Food Processing and Food Handling Establishments, Dining Rooms, etc.): In Food Areas, application is limited only in areas where food and feed stuff are received, stored, prepared, packaged (canning, boxing, or wrapping) or served. Do not use in edible product areas of food handling establishments, restaurants or other areas where food is commercially prepared or processed. Care must be taken to avoid depositing this product on serving surfaces where food and feed stuff are processed or exposed. Avoid areas likely to be contacted by food. Non-Food Areas: Apply around water pipes in areas such as garbage rooms, locker rooms, mop closets, boiler rooms and lavatories.

Application Methods: Drax Liquid Ant Killer II - SWT can be applied to pieces of cardboard, plastic tubing, refillable plastic bait stations, and on absorbing material (cotton balls, sponge, etc.) within a plastic dish. Drax Liquid Ant Killer II - SWT can be dispensed directly from the container or by using a dropper or pipette. Put ¼ to ½ teaspoon of Drax Liquid Ant Killer II - SWT on the pieces of cardboard. Plastic tubing should be placed horizontally and filled ¼ to ½ full. Absorbing material should be moderately soaked with the liquid bait. Refillable plastic bait stations should be filled ¾ full. Note to User or Pest Control Operator: Tape or attach the enclosed "CAUTION" stickers to the refillable bait stations. The "CAUTION" sticker will include the following information: 1) name of product 2) EPA Reg. Number 3) Ingredients and percentage 4) precautionary statements and 5) Signal Word.

### STORAGE & DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in original container away from food and feedstuffs. Keep product in a locked storage a 66 c c DISPOSAL: If empty: Do not reuse this container. Place in trash or offer for recycling if available. If partly filed: Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
