- 6. On page 3, under the "Optional Quick Reference Chart" remove "sedges" for "preemergence control. It is on the cited labeling for "postemergence control of sedges".
- 7. On page 4, correct the spelling of "With" in the heading.
- 8. Submit the results of one year storage stability (830.6317) and corrosion characteristics (830.6320) studies on completion. It is recommended that observations be made at 0, 3, 6, 9, and 12 month intervals.
- 9. The label must be revised for ingredient statement changing the nominal concentrations of the active ingredient sulfentrazone from 0.385% to 0.386% and that of dithiopyr from 0.514% to 0.515%, so that this information concurs on the label and the Confidential Statement of Formula.

Submit one copy of the revised final printed label before the product is released for shipment.
