Shake Well Before Using

Read entire label and follow all label directions.

Use this product as a broadcast, spot or crack and crevice treatment to areas where pests are seen or suspected only. Spot treat surfaces until visibly wet. Apply to listed pests directly, whenever possible. A single can treats up to 2000 sq ft.

Use Restrictions

Do not treat pets with this product.

Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift.

Do not allow adults, children, or pets to enter the treated area until sprays have dried.

Remove pets, birds and cover fish aquariums before spraying.

Remove or cover exposed food and drinking water before application.

Do not apply directly to animals.

Avoid contamination of food and feedstuffs. Remove or cover dishes, utensils, food processing equipment and food preparations surfaces or wash them thoroughly after treatment and before use.

Pay special attention to areas behind and beneath sinks, stoves, refrigerators, garbage containers, inside cabinets, along baseboards, in cracks and crevices in walls and floors, door and windowsills and frames, around drains, pipes, plumbing, bookcases, storage and utility areas, and utility installation areas.

Retreat for roaches after 120 days [17 weeks] [4months]. Retreat for all other listed insects after 210 days [30 weeks] [7 months].

To control carpet beetles:

Thoroughly vacuum rugs and carpets before treatment. Remove the vacuum bag and place it in a separate bag and dispose of in outside trash. This helps prevent reinfestation from eggs and larva vacuumed up.

Spray backing of carpet and rugs and edges of carpeting, focusing on low traffic areas, and areas under furniture.

Retreat after 210 days [30 weeks] [7 months].

For use inside of transportation vehicles: (Automobiles, Boats, Campers, Mobile Canteens, Mobile Homes, Railroad Cars, Recreation Vehicles, Ships, Trailers, and Trucks)

To control ants, cockroaches, crickets, centipedes, firebrats, pillbugs, silverfish, spiders, and sowbugs:

Directly spot treat listed pests when they are seen. Spot treat ant trails and spray cracks and crevices and points of entry into the house. Pay special attention to areas behind and beneath sinks, stoves, refrigerators, garbage containers, inside cabinets, along baseboards, in cracks and crevices in walls and floors, door and window sills and frames, around drains, pipes, plumbing, bookcases, storage and utility areas, and utility installation areas.

Retreat for roaches after 120 days [17 weeks] [4months]. Retreat for all other listed insects after 210 days [30 weeks] [7 months].

For controlling fleas from pets, follow the instructions within the section "pet areas (indoors only)" below.

For use in commercial areas: (Atriums, Crematoriums, Day Care Centers, non-food areas of [Cafeterias, Dormitories, Drug Stores, Food Processing Facilities, Hospitals, Hotels, Indoor Eating Establishments, Nursing Homes, Restaurants, Schools, Institutions, Jails and Mess Halls, Supermarkets, Taverns, and Theaters], Dumpsters [inside only], Factories, Funeral Parlors, Locker Rooms, Mausoleums, Morgues, Mortuaries, Office Buildings, Public Buildings, Prisons, Quonset huts, Stadiums, Storage Areas, and Washrooms)

To control ants, cockroaches, crickets, centipedes, firebrats, pillbugs, silverfish, spiders and sowbugs:

Directly spot treat listed pests when they are seen. Spray cracks and crevices and points of entry into the house. Pay special attention to areas behind and beneath sinks, stoves, refrigerators, garbage containers, inside cabinets, along baseboards, in cracks and crevices in walls and floors, door and window sills and frames, around drains, pipes, plumbing, bookcases, storage and utility areas, and utility installation areas.

Retreat for roaches after 120 days [17 weeks] [4months]. Retreat for all other listed insects after 210 days [30 weeks] [7 months].

For use in the following pet areas (indoors only):

To control fleas and ticks: Cat Sleeping Areas, Dog Houses, Kennels, Pet Bedding, Pet Carriers, Pet Grooming Areas, Pet Sleeping Areas, Pet Stores, Veterinary Offices

Thoroughly vacuum all carpeting and fabric covers, furniture, along baseboards, under furniture, low traffic areas, and areas where pets normally rest. Place vacuum bag in a separate bag and dispose of in outside trash. Thoroughly spray pet resting areas, infested upholstered furniture, entire floor and floor coverings with special attention to window and door frames, and cracks and crevices along baseboards where pests are suspected.

Remove and wash and replace pet bedding after insecticide has dried.

If flea and tick infested areas are transported in vehicles, use as a spot treatment to carpets and upholstered areas, paying attention to cracks and crevices.

Retreat after 210 days [30 weeks] [7 months].

[Non-product related instructions associated with fleas only:]

To further protect your pet and your home from continuing reinfestation by fleas, you should use an EPA registered (labeled) product to treat the animal(s) before the animal is allowed back into the house. You should also treat the area in the yard where the pet typically spends time with an EPA-registered (labeled) product specifically for yard flea control. The pet, home, and yard should be treated at the same time.

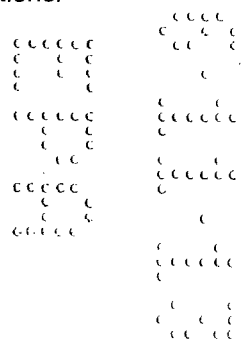
STORAGE & DISPOSAL
