Dear Ms. Holihan:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

In the case of fleas, biting adult fleas will not result from treated immature fleas and the reproductive life cycle is broken. Treatment will last for 210 days [30 weeks] [7 months] for fleas and 120 days [17 weeks] [4 months] for cockroaches.]



CAUTION

For Indoor Use Only

Read entire label and follow all label directions.

Use this product as a broadcast, spot or crack and crevice treatment to areas where pests are seen or suspected only. Treat surfaces until visibly wet. Apply to listed pests directly, whenever possible. Use F9144 at the rate of 17 oz. for up to 1,700 sq. ft. This product contains a combination of ingredients to provide rapid [quick] knockdown and kill of the listed pests as well as an insect growth regulator which prevents immature cockroaches and fleas that are sprayed or that contact the insecticide residue from becoming adults. **Shake Well Before Using**

Use Restrictions

- For Indoor Use Only
- Do not treat pets with this product.
- Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift.
- Do not allow adults, children, or pets to enter the treated area until sprays have dried.
- Remove pets, birds and cover fish aquariums before spraying.
- Remove or cover exposed food and drinking water before application.
- Do not apply directly to animals.
- Do not contaminate food and feedstuffs. Remove or cover dishes, utensils, food processing equipment and food preparations surfaces or wash them thoroughly after treatment and before use.
- Do not use in food handling establishments in which food is held, processed, prepared and/or served. When used in the home, cover or remove all exposed food and cooking utensils and cover all food processing surfaces and wash thoroughly after treatment and before reuse.
- Do not use in aircraft.

For Fleas and Carpet Beetles:

Use F9144 at the rate of 17 oz. for up to 1,700 sq. ft. Thoroughly vacuum all carpeting and fabric covers, furniture, along baseboards, under furniture, low traffic areas, and areas where pets normally rest. Place vacuum bag in a separate bag and dispose of in outside trash. Launder small rugs, pet bedding, disassembled sofa cushions, and other similar fabric items before treatment. Treat infested areas by thoroughly spraying pet resting areas, infested upholstered furniture, entire floor and floor coverings with special attention to window and door frames, and cracks and crevices along baseboards where pests are suspected. Hold F9144 36 inches from the surface being treated and spray downward. An area of 80-90 sq. ft. can be treated in approximately 10 seconds with F9144. Treat crack and crevices in upholstered furniture where flea development occurs. **Remove and wash and replace pet bedding after insecticide has dried.**

[Non-product related instructions associated with fleas only:]

To further protect your pet and your home from continuing reinfestation by fleas, you should use an EPA registered (labeled) product to treat the animal(s) before the animal is allowed back into the house. You should also treat the area in the yard where the pet typically spends time with an EPA-registered (labeled) product specifically for yard flea control. The pet, home, and yard should be treated at the same time.

For the control of all labeled crawling insect pests (including inside of Transportation Vehicles):

Directly spot treat listed pests when they are seen. Spot treat ant trails and treat cracks and crevices and points of entry. Pay special attention to areas behind and beneath sinks, stoves, refrigerators, garbage containers, inside cabinets, along baseboards, in cracks and crevices in walls and floors, door and windowsills and frames, around drains, pipes, plumbing, bookcases, storage and utility areas, and utility installation areas. If flea and tick infested areas are transported in vehicles, use as a spot treatment to carpets and upholstered areas, paying attention to cracks and crevices.

STORAGE & DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store in cool dry area. Always store pesticides in the original container. Store away from food and pet food.

Pesticide Disposal and Container Handling: Do not Puncture or Incinerate! Non-refillable container. Do not reuse or refill this container. If empty: Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency for disposal instructions.
