The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Clomazone Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage

Do not store below 25°C. Product may crystallize at temperatures below 25°C (77°F). In the event that crystallization occurs, the material may be melted at temperatures not to exceed 85°C (185°F). Store in original containers only. Store in a dry place and avoid excess heat. Carefully open containers. After partial use, replace lids and close tightly. Do not put concentrate or dilute material into food or drink containers. Do not contaminate other pesticides, fertilizers, water, food or feed by storage or disposal.

In case of spill, avoid contact, isolate area and keep out animals and unprotected persons. Confine spills. Call CHEMTREC (Transportation and Spills): 800-424-9300.

Container Handling

Metal Isotainers: Refillable container. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. Clean and rinse with detergent and water as follows: empty the remaining contents into a holding drum and continue to drain for 10 seconds after the flow begins to drip. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

Metal Drums: Nonrefillable container. Do not reuse or refill this container. Triple rinse [or pressure rinse] as follows: Triple rinse: Empty the remaining contents into a storage container or a mix tank. Fill the container ½ full with appropriate solvent (1). Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into a storage container for later use or disposal, or into a mix tank for product formulation. Repeat this procedure two more times.

Then offer for recycling, if available, or reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

Pressure rinse: Empty the remaining contents into a storage container or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over storage container or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

(1) An appropriate solvent would include a solvent that will dissolve technical material. The rinsate may be used later to formulate a product or may be disposed in accordance with local, state and national environmental laws, rules, standards and regulations.
