"To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Restricted Use Pesticide

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. Resistance Management

For resistance management, please note that F4120-2 contains both a Group 3A insecticide and Group BM 02 fungicide. Any insect population may contain individuals naturally resistant to F4120-2 and other Group 3A insecticides. Likewise, any fungal population may contain individuals naturally resistant to F4120-2 and other Group BM 02 fungicides. The resistant individuals may dominate the insect population if Group 3A insecticides are used repeatedly in the same fields. A gradual or total loss of pest control may occur over time if Group BM 02 fungicides are used repeatedly in the same fields. Appropriate resistance-management strategies should be followed.

To delay insecticide and fungicide resistance, take one or more of the following steps:

- Rotate the use of F4120-2 or other Group 3A insecticides and Group BM 02 fungicides within a growing season, or among
 growing seasons, with different groups that control the same insect pests or fungal pathogens.
- Use tank mixtures with insecticides and fungicides from a different group that are equally effective on the target pest when such use is permitted. Use at least the minimum application rate as labeled by the manufacturer. Do not rely on the same mixture repeatedly for the same pest population. Consider any known cross-resistance issues (for the targeted pests) between the individual components of a mixture. In addition, consider the following recommendations provided by the Insecticide Resistance Action Committee (IRAC):
 - Individual insecticides selected for use in mixtures should be highly effective and be applied at the rates at which they
 are individually registered for use against the target species.
 - Mixtures with components having the same IRAC mode of action classification are not recommended for insect resistance management.
 - When using mixtures, consider any known cross-resistance issues between the individual components for the targeted nests
 - Mixtures become less effective if resistance is already developing to one or both active ingredients, but they may still
 provide pest management benefits.
 - The insect resistance management benefits of an insecticide mixture are greatest if the two components have similar periods of residual insecticidal activity. Mixtures of insecticides with unequal periods of residual insecticidal activity may offer an insect resistance management benefit only for the period where both insecticides are active.
- Adopt an integrated pest and disease management program for insecticide and fungicide use that includes scouting, uses
 historical information related to pesticide use, crop rotation, record keeping, and which considers host plant resistance, impact
 of environmental conditions on disease development, disease thresholds, as well as cultural, biological and other chemical
 control practices.

Application and Mixing Instructions

F4120-2 is an insecticide/fungicide for in-furrow at plant applications. This product contains 1.4 pounds per gallon of the insecticide bifenthrin together with the biopesticide *Bacillus amyloliquefaciens* strain D747 at a minimum of 1x 10¹⁰ colony-forming units (cfu) per milliliter. *Bacillus amyloliquefaciens* strain D747 is a naturally occurring beneficial bacterium used for early season suppression of fungal plant diseases. The rate of application is variable according to pest pressure. Use lower labeled rates under light to moderate pest infestations, and higher labeled rates under heavier pest pressure. In arid climates application rates are generally higher. F4120-2 must be used in equipment designed specifically for application of this type of formulation.

F4120-2 must be applied in-furrow with the seed or transplant.

Do not mix with any other product unless that product has been specifically designed to work with the F4120-2 formulation.

Use rates in the individual crop sections are listed as Fluid oz/1000 Linear feet based on 30-inch row spacings. For conversion to rates applicable to different row spacings, see the table below.

Do not exceed the maximum application rate per acre per year (lb ai/A/year) as listed under the use directions for each crop.

VEGETATIVE FILTER STRIPS

Construct and maintain a vegetative filter strip, according to the width specified below, of grass or other permanent vegetation between the field edge and nearby down gradient aquatic habitat (such as, but not limited to, lakes; reservoirs; rivers; streams; marshes; or natural ponds; estuaries; and commercial fish farm ponds).

Only apply products containing bifenthrin onto fields where a maintained vegetative filter strip of at least 25 feet exists between the field edge and where a down gradient aquatic habitat exists. This minimum required width of 25 feet may be reduced or removed under the following conditions:

- For Western irrigated agriculture, a maintained vegetative filter strip of at least 10 feet wide is required. Western irrigated agriculture is defined as irrigated farmland in the following states:
 - WA, OR, CA, ID, NV, UT, AZ, MT, WY, CO, NM, and TX (west of I-35).
 - o For Western irrigated agriculture, if a sediment control basin is present, a vegetative filter strip is not required.
- In all other areas, a vegetative filter strip with a minimum width of 25 feet is required, unless the following conditions are met. The vegetative filter strip requirement may be reduced from 25 feet to 15 feet if at least one of the following applies:
 - o The area of application is considered prime farmland (as defined in 7 CFR § 657.5)
 - Conservation tillage is being implemented on the area of application. Conservation tillage is defined as any system
 that leaves at least 30% of the soil surface covered by residue after planting. Conservation tillage practices can
 include mulch-till, no-till, or strip-till.
 - A functional terrace system is maintained on the area of application.
 - o Water and sediment control basins for the area of application are functional and maintained.
 - The area of application is less than or equal to 10 acres.

Crop Rotation Restrictions

Crops for which bifenthrin tolerances exist may be rotated at any time. All other crops may be rotated 30 days following the final application of bifenthrin.

Maximum Allowable F4120-2 Use per Acre per Year

Refer to the individual crop sections for maximum allowable F4120-2 usage per acre per year. The maximum allowable use of the bifenthrin active ingredient must include all registered use patterns including at-plant, soil applied and foliar applications of all bifenthrin containing products for a 12-month period. The 12-month period is to begin upon the initial application to the acre.

BUFFER ZONES TO WATER BODIES

Ground Application

Do not apply within 25 feet of aquatic habitats (such as, but not limited to lakes, reservoirs, rivers, streams, marshes, ponds, estuaries, and commercial fish ponds).

In New York State, this product may not be applied within 100 feet (using ground equipment) of coastal marshes or streams that drain into coastal marshes.
