Resistance Management:

F4278-3 contains the active ingredient Flutriafol which is a member of FRAC group 3 and is a demethylation inhibitor (DMI).

Any fungal population may contain individuals naturally resistant to F4278-3 and other Group 3 fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same fields. Appropriate resistance-management strategies should be followed.

To delay fungicideresistance, take one or more of the following steps:

- Rotate the use of F4278-3 or other Group 3 fungicides within a growing season sequence with different groups that control the same pathogens.
- Use tank mixtures with fungicides from a different group that are equally effective on the target pest when such use is permitted. Use at least the minimum application rate as labeled by the manufacturer.
