DIRECTIONS

BEEF CATTLE: For the control of Lice, Ticks and Horn Flies, use 1 quart of Martin's 50% MALATHION CONCENTRATE to 20 gallons of water. Spray animals thoroughly. Repeat at 2 week intervals if necessary. Do not apply to lactating Dairy animals.

SHEP AND GOATS: For the control of Lice, Ticks, and Keds, use 1 quart of Martin's 50% MALATHICN CONCENTRATE to 20 gallons of water. Spray animals thoroughly. Repeat application after 2 to 3 weeks if necessary.

HOGS: For the control of Lice, use 1 quart of Martin's 50% MALATHION CONCENTRATE to 20 gallons of water. Apply thoroughly to the animals, pens and litter. Repeat only if necessary.

DOGS AND CATS: For the control of Fleas, use 2th tablespoons of Martin's 50% MALATHION CONCENTRATE to each gallon of water. For control of Fleas in the animal's quarters, use 12 tablespoonfuls of Martin's 50% MALATHION CONCENTRATE to each gallon of water. Repeat applications if necessary, should not be more often than once a week.

FLY CONTROL: For the sontrol of Flies, mix 21 quarts per 100 gallons of water. Spray on walls, fences, garbage containers, and where ever flies congregate and breed. Wet all surfaces thoroughly. The addition of 8 tablespoonfuls of sugar per gallon will increase the effectiveness of the spray.

FRUITS: (Apples, Peaches, Pears and Plums) For the control of Spider Mites, Griental Fruit Moth and Plum Curculio. For the control of Red Spider Mites, Mealy Bugs, Woolly Aphis, Pear Psyllid and Japanese Beetle (Adultak use 12 to 2 tablespoonfuls of Martin's 50% MALATHICM CONCENTRATE to 1 gallon of water. Do not make application on fruits 7 days before harvest.

PECAN TREES: For the control of Pecan Nut Casebearer, Pecan Phylloxera. Pecan Budmoth, Spider Mites and Aphids, use 2 tablespoonfuls of Martin's 50% MALATHICM CONCENTRATE to 1 gallon of water.

ORNAMENTALS: Can be used on Roses, Camellias, Azaleas, Chrysanthemum, Evergreens, and many other flowers and shrubs for the control of Aphids, Birch Leaf Minor, Japanese Beetles (Adult), Lace Bugs, Leaf-hoppers, Mealy Bugs, Tarnished Plant Bugs, Thrips, and Whiteflies; use 1 teaspoonful per gallon of water. For the control of Bagworms, Tent caterpillars, Black Scale Crawlers, Leaf Scales, Oyster Shell Scale, Soft Brown Scale, and Spider Mites; use 2 teaspoonfuls per gallon of water. Do not use on certain ferns including Boston, Maidenhair, and Pteris, as well as on some species of Crassula.

VECETABLES: Can be used on Tomatoes, Potatoes, Peas, Beans, Peppers, Cabbage, Broccali, Cucumbers, Squash, and Melons, for the control of Aphids, Spider Mites, Leafhoppers, Mexican Bean Beetles and Imported Cabbage Worms, use I teaspoonful per gallon of water. For the control of Onion Thrips on onions use 2 teaspoonfuls per gallon of water. DO NOT USE later than 3 days before harvest on the above vegetables with the exception of Cabbage and this should not be applied later than 7 days before harvest.

HOUSEHOLD PESTS: For the control of Roaches, Ants, Spiders, Silverfish, Crickets, Clover Mites and Earwigs, use 8 tablespoonfuls of Martin's 50% MALATHION CONCENTRATE to 1 gallon of water. Apply by means of coarse spray or paint brush to windowsills, base boards, drainboards, under sinks, stoves and to other areas frequented by insects.
