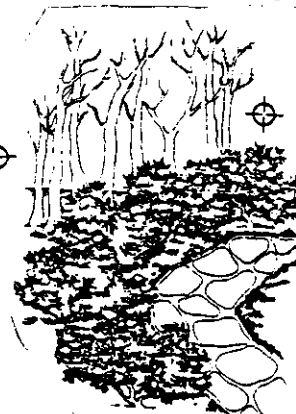

DIRECTIONS FOR USE

(Continued)

and dichondra lawns, apply Diazinon® Granular Lawn Insect Control at a rate of 8 oz. per 100 sq. ft. or 5 lbs. per 1000 sq. ft. For heavy lawns such as St. Augustine lawns, application should be increased to 12 oz. per 100 sq. ft. or 7½ lbs. per 1000 sq. ft. Make even application over entire lawn when grass is dry. Water lawn lightly after application. Repeat as necessary.

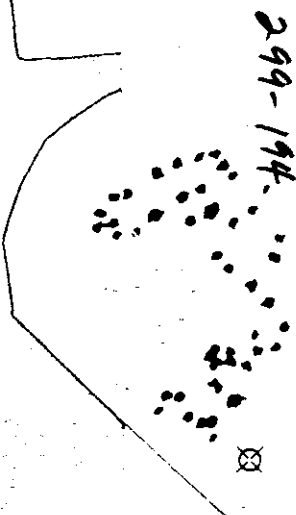
For control of Billbugs, and White Grubs of Japanese Beetle, European Chafer and Souther Chafer, apply 6 lbs. per 1000 sq. ft. of lawn. Water grass thoroughly after application. For grub control make application any time between late July and early October. For Billbug control, apply when activity is first observed. Repeat as necessary.

Spot Treatment: For Ants apply one tablespoon of Diazinon® Granular Lawn Insect Control over and around each individual ant hill.

For Digger Wasps, apply one tablespoon in and around each individual ground nest opening. Make application about dusk when the wasps are not active.

Band Treatment Around Foundation: For Ants, Brown Dog Ticks, Clover Mites, Crickets, Earwigs, Fleas, Millipedes, Sowbugs, and Springtails found around or near the foundation of houses, apply a five foot band of Diazinon® Granular Lawn Insect Control next to the foundation of the house. Distribute the granules uniformly using a rate of 8 oz. for each 5 ft. by 20 ft. area to be treated.
