The amendments referred to above, submitted in connection with registration under section 3(c)(7)(A) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), to add disinfection claims against <u>Enterococcus faecalis</u> - Vancomycin Resistant on hard, nonporous inanimate surfaces in the presence of 5% fetal bovine serum and 400 ppm of synthetic hard water when used at a dilution of 1:256 (0.5 ounce/gallon) (providing 600 ppm of active quaternary) when thoroughly wetted and allowed to remain wet for a contact time of at least 10 minutes are acceptable provided that you comply with the items below.

- 1. Submit/cite all data required for registration/reregistration of your products under FIFRA section 3(c)(5) and section 4 when the Agency requires all registrants of similar products to submit such data.
- 2. Submit five (5) copies of your final printed labeling before you release the products for shipment.



- 1. Remove all animals and feeds from premises, trucks, coops, crates, and enclosures.
- 2. Remove all litter and manure from floors, walls, and surfaces of barns, pens, stalls, chutes, vehicles, and other facilities and fixtures occupied or traversed by animals.
- 3. Empty all troughs, racks, and other feeding and watering appliances.
- 4. Thoroughly clean all surfaces with soap or detergent, and rinse with water.
- 5. Saturate all surfaces with the recommended disinfecting solution for a period of 10 minutes.
- 6. Immerse all halters, ropes, and other types of equipment used in handling and restraining animals, as well as forks, shovels, and scrapers used for removing litter and manure.
- 7. Ventilate buildings, coops, cars, boats, and other closed spaces. Do not house animals or employ equipment until treatment has been absorbed, set, or dried.
- 8. After treatment with disinfectant, thoroughly scrub feed racks, troughs, automatic feeders, fountains, and waterers with soap or detergent, and rinse with potable water before reuse.
