Enclosed please find our Notification per PR Notice 98-10 to change the warranty statement on the Master Label for the subject product. We are also taking this opportunity to submit the label in a revised two column landscape format and update the address. Finally, please note per my e-mail correspondence with Joe Tavano of your team in November, 2003, that a box format for Storage & Disposal is optional. We would like to retain the option of presenting Storage & Disposal and First Aid in paragraph formats rather than boxes when the actual container label is small, as they often are for insect repellents.


This notification is consistent with the provision of PR Notice 98-10 and the requirements of EPA regulations at 40 CFR 156.10 and 152.46 and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 40 CFR 156.10 and 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.
