- 1. Remove all names from your label that use the acronym "IPF" (Insect Protection Factor) per my letter dated July 18, 1994. Theses names are unacceptable and cannot be used.
- 2. In the ingredient statement on the labels for EPA Reg. Nos.305-40 and 305-44, revise the total to equal "100.00%".
- 3. The label for EPA Reg. No. 305-44 directs the user to "Avoid contact with plastics, acetate, spandex, and nylon." On the other hand, the labels for EPA Reg. Nos. 305-40 and 305-49 direct the user as follows "Do not apply to synthetic fabrics, such as acetate, rayon or spandex. Will not damage cotton, wool, and nylon." Please revise the labels accordingly to make this directive the same on each label.
